Richard was born in New Orleans, graduated from high school in Atlanta, graduated from Dartmouth College, Union Theological Seminary in Virginia, and, with the PH.D, from The University of St. Andrews. Served churches in Arkansas, Virginia, and Tennessee. Taught at Stephens College and Pittsburgh Theological Seminary. Was the Managing Director and Senior Editor of John Knox Press, Director of the Children's Trust Society of the Grandfather Home for Children, and, for two and a half years, was the Interim President of King University. Is currently the General Editor of Kerygma Bible Studies and Chairman of the Board of Directors of the Presbyterian Heritage Center in Montreat. Richard is married to Lila, and we have three children with in laws and eight grandchildren.

Rev. Dr. Charles E. Raynal, III

Charles Raynal graduated from D. W. Daniel High School in Six Mile, SC (1961); Davidson College (1965); Union Presbyterian Theological Seminary (1969); and Yale University Graduate School (1973). After serving Presbyterian Churches in Durham, NC; Hammond, LA; and Davidson, NC (1979-1999), he became Director of Advanced Studies, Columbia Theological Seminary, Decatur, GA and in 2009 retired as Professor of Theology Emeritus. He and his wife Rosemary live in Davidson.

Rev. Dr. Thomas Hay

Tom is an Associate Stated Clerk and Director of Assembly Operations at the Office of the General Assembly in Louisville. He has been with the OGA since January of 2009. Mid-Century Change in Historic Denominations

NANCY SNELL GRIFFITH CHARLES E. RAYNAL

The history of South Carolina Presbyterians between 1925 and 1985 covers a period of great development achieved through many difficulties in church and society. We tell the story not only of the churches belonging to the PCUS, sometimes called "southern Presbyterians," but also African American churches and institutions in South Carolina established after the Civil War by PCUSA missionaries from the North. For all Presbyterians, events between the World Wars challenged the moral stances birthed by Protestants to build a Christian America. Women's right to vote came to the nation in 1920, but claiming equality of women's roles in mainline churches took decades of advocacy. The Great Depression engulfed the whole nation, eroding funds for churches, missions, and institutions. World War II set the scene for a great period of church expansion. When moral and cultural challenges came from the Civil Rights Movement and the war in Vietnam, the church increasingly began to face these issues and tensions, both theological and social, as they arose among the members of historic denominations. An effort began to reintegrate African American churches into the Synod of South Carolina. As the Synod of South Carolina was taken up into a larger regional body in 1973, its more conservative churches began to withdraw from the PCUS. Many congregations began to shrink and the resources for mission diminished. In telling this story we hope to provide insights into how Presbyterians in South Carolina contributed to culture, connecting their religious life and practices to a larger social setting. May a fresh look at the recent past stir us to renewal ahead.



The Coordinating Council **reports**:

- 1. That it held its first meeting according to the new model Presbytery adopted and approved at the 2016 Summer and Fall Stated Meetings of Presbytery on Tuesday, January 10, 2017. The new members were welcomed.
- 2. That it approved the gift of property to, and the sale of that property by the Fountain Inn Church.
- 3. Noted that, per an action of Council in 2015, that the van, formerly used at the Buc Outdoor Center, was given to the Salem Church for their repair and use in the Dream Grant Project.
- 4. Approved the contract for the Buc Outdoor Center Site Manager for 2017.
- 5. Approved the members for the 2017 Buc Outdoor Center Site Management Committee: Cal Cannon and Scott Tompkins (First Greer) and Alan Workman (First Spartanburg).
- 6. Received updates from the Special Task Forces: Seminary Scholarships, Campus Ministry, Youth Ministry and BOC Task Force. Leigh Stuckey, Chair of the Youth Ministry Task Force was present. Council approved the use of funds to hire Ministry Architects to assist the Youth Ministry Task Force in assessing Presbytery's youth work.
- 7. Heard a report about the continuing work of The Small Church Working Group. Quarterly gatherings will continue in 2017. This year the site of the meetings will rotate across the three regions of Presbytery. The next meeting focused on small church's engagement in the new model of Presbytery.
- 8. Noted that the work on the complete Manual of Operations of Foothills Presbytery continues. The Sexual Ethics Policy is under review. A special committee is working on the Child, Youth, Vulnerable Adult Safety Policy. The Personnel Committee is working on the Personnel Policy. All of these will come before Presbytery for the required two readings approval when work on the drafts are completed.
- 9. Noted that the General Assembly Advisory Committee on Social Witness Policy will hold their winter meeting in Foothills Presbytery, and that members of Foothills Presbytery's General Assembly Reform Group will meet with them, that some members of ACSWP will be available for Sunday School Classes, and that they will host a forum about two parts of their present work.

- 10. That it formally approved the invitations to Rev. Dr. Frank Colcough and Rev. Dr. Charles E. Raynal, III to lead Presbytery in a celebration of our Reformed and Presbyterian History in South Carolina (see attached advertisement for the book their presentation will be based in); the invitation to Rev. Dr. Richard Ray, of the Montreat Heritage Society, who will make a presentation about the May "Reformation at 500" conference in Montreat; and the invitation to the Rev. Dr. Thomas Hay, Associate Stated Clerk for General Assembly Operations who make a brief presentation about the work of the General Assembly.
- 11. Noted the dates and places of the three remaining Stated Meetings of Foothills Presbytery in 2017: April 30th at the Nicholtown Church (hosted by the Racial Ethnic Cabinet), August 13th (TBD) and November 14 at Easley Presbyterian Church.
- 12. Heard a report from all the committees, and reviewed and approved the new model for the Docket. The following Committees will report: Bills and Overtures, Finance and Stewardship, Nominations, Committee on Ministry, the Examinations Commission, Committee on Preparation for Ministry, and the Committee on Shared Ministry.

The information offered will be helpful for those who are new to the office of Clerk of Session, first time Elders, new pastors and those who whose background is not Presbyterian. The committee believes sharing information and addressing questions will bring more continuity to the formatting and content of session minutes throughout Foothills Presbytery.

Please remember that the Financial Review or Audit Form must be submitted this year along with the minutes for each church. A sample of the form is attached to this report. The document will be sent along with the Clerk's check list for readings.

That it met on Thursday, January 19, 2017, at the presbytery office. Members present: Amos Workman (co-moderator, presiding), Jean Deiner Weaver (co-moderator), Jim Caprell, Patty Felton, Nan Jones, Ann Coleman, Ted Morrison, and Bill Burns. The meeting was opened with prayer.

Candidate for ordination Jason Moore gave his statement of faith, described his sense of call, and preached a sermon for the Commission based on Mark 4:26-29. His sermon was approved. He was successfully examined in the areas of Bible, theology, sacraments, and polity. He stated no scruple and affirmed his commitment to abide by our church's polity and discipline. His examination was approved and he will appear before the presbytery for floor examination at its meeting on February 21. Terms of call were approved. Ordination and installation commission members are yet to be named.

A mentor will be named. The exam was closed with prayer.

- Teaching Elder James Lewis Johnson, Sr., honorably retired, met with the Commission, requesting transfer of membership to Foothills from New Harmony Presbytery. He gave his statement of faith and described his calling and career since ordination. He was successfully examined in the areas of Bible, theology, sacraments, and polity. Jason Moore Call and Faith Statements

Biography

I usually say that I grew up "close to" Florence, South Carolina because you can actually find that on a map. In reality, I grew up in the rural farming community of Hebron, which is little more than a crossroads and collection of houses and fields. There we had more churches than stoplights, and more animals than people. My early days were spent loping through the woods, and chasing fly-balls on a scrubby baseball field. Truth be told, my first love was baseball, and while in those days it wasn't yet a year round sport, it was for me. Church, however, was an after-thought. As a family, we went sporadically. We weren't "Chreasters," but we weren't much better. Yet in spite of our slipshod attendance, I can't remember a time when I didn't believe in God. Even then, the Bible seemed more real to me than other books. The stories grabbed me by the throat and wouldn't let me go. By the time I was Confirmed as a teenager, we were attending more regularly, and I was even starting to study the Bible on my own. Later in high school, I was asked to preach for Youth Sunday. I was struck by the immensity of the task. I've never gotten over it. Afterwards, people talked about my gift and my calling, but I had other plans. God may have been calling, but I wasn't ready to answer.

After graduation from high school, I attended the University of South Carolina where I graduated with a BA in English. In the meantime, I served as counselor and trip leader at Camp Pee Dee, a PC(USA) camp down in Bennettsville, SC. It was while I was there—leading canoe trips and devotions around a campfire—that God seemed to speak again. Nothing major. Much more like the still small voice that came to Elijah than the burning bush that Moses encountered. It was also during these summers when I started participating in Salkehatchie Summer Service. It was my first real mission experience. And while some hear God speak through a beautiful anthem on a Sunday morning, for me it was in a chorus on hammers as we shingled a roof in the baking summer sun. But I didn't know what to do with any of this. And since I hadn't taken any education classes, I wasn't sure of what to do with my English degree, either. So I took a job as a substitute teacher at my old high school.

When the year ended, God opened a door for me as a Youth Director and Director of Christian Education. I started attending seminary a year later. After four years of full-time ministry, I was burned-out and disillusioned. Frankly, I didn't think ministry would be that hard. So I took the easy way out and joined the Marine Corps. I was commissioned as a Second Lieutenant in December 2004. Over the next eight years, I served as a Logistics Officer, including combat deployments to both Iraq and Afghanistan.

In August 2013, I answered God's call to ministry and having been serving as the Director of Youth Ministry at First Presbyterian Church in Spartanburg. It feels like I've come full circle, and yet in the providence of God, I know that none of this has been wasted. My experiences both in and out of church, both stateside and during the hardship of combat, have provided me with a unique perspective and a wealth of experiences. While some go away to war and "lose their faith," for me it was just the opposite. For it was while I was leading Marines in combat that God birthed in me a burning desire to preach and teach his Word, and to shepherd his people. Along the way, God has blessed me with a wonderful family. My wife, Melanie, and I have been married for eleven years and have two children—Clara (7) and Benjamin (4).

Jason Moore Call and Faith Statements

Statement of Faith

There is one God in three Persons--Father, Son, and Holy Spirit. I often think of God the Father as Creator, the Son as Savior and Lord, and the Holy Spirit as Sustainer and Counselor. "They" are equal, eternal, immutable, holy, righteous, loving, and just. "They" are all fully God, distinct from each other, and yet exist in perfect unity and harmony. This, of course, is a profound mystery. At its best, the Church emulates both the unity and community of God albeit imperfectly.

I believe that God created me for his own glory, and that God has effectively called and redeemed me. As I follow and seek to emulate Christ, he continues to sanctify me, until I am raised from death in glory.

In the fullness of time, God sent his Son Jesus into the world as the supreme act of selfgiving love. Jesus lived a perfect life, and willingly gave his life so that everyone who believes in him will be saved (In. 3:16). Yet even my belief is a gift of God; salvation is the work of God from start to finish (Eph. 2:8). Apart from God's gracious initiative, I would have no hope in this life or the life to come. Though I cannot earn his love, I am empowered through the Holy Spirit to respond to his grace and live a life of faithful obedience, and complete the work He has planned in advance for me to do. Just as God has reconciled me through the cross, I am given the ministry of reconciliation, so that all who are far off might be brought near (Eph. 2:17). In this way, my relationship with God colors everything I do. It has rearranged my priorities and commitments, and it touches every decision I make. I believe that God has revealed Himself in creation (Ps. 19; Rom. 1:19-20). Creation testifies to the wisdom, majesty, and incredible generosity of God, yet General Revelation alone could not save us from our sin. Thus, God lovingly reveals himself in the person of Christ and in both the Old and New Testament Scriptures. Here, everything that is necessary for our salvation and the living of the Christian life is laid out before us. This Word is true, authoritative, complete, and sufficient. Because our minds have been darkened by sin, we need the Holy Spirit to illuminate God's Word. In addition, God has graciously provided faithful men and women who have come before us and worked together in order to provide summaries of the essential doctrines of our faith. Thus, the creeds and confessions found in our Book of Confessions can guide us in our understanding of Scripture. Even so, they are--and must always be--subordinate to God's Word. I believe the Church is the gathering of God's people. The Church is a hospital for sinners; it is not a hotel for saints, or merely another social action club. The Church is where the Word is proclaimed, and the Sacraments (Baptism and the Lord's Supper) are rightly administered. These Sacraments are gifts from God—visible signs of his invisible grace. Christians are made for community, and our faith is strengthened through the teaching. admonishment, and encouragement of one another. Thus, having been claimed, fed, and nurtured, the Church sends us out into the world share God's grace and make disciples of Christ.

James Lewis Johnson Biography/ Call Statement

I am James "Lewis" Johnson. I live on Lake Bowen with my wife Janet and our dog Belle of the Kirk. I have, recently, finished 13 years of service as an Interim Pastor. I served in Pastoral ministry from 1959 to 2002 prior to a period of interim ministries. I make this distinction because it represents the two phases of my call experience.

From early childhood the church was a constant and shaping force in my life. Sunday School, worship, and service were part of who I was. My minister and his wife acted as though I was their child to guide through prayer and study. They were like second parents.

In my teens I sensed a call to Christian ministry and pursued that call through college and seminary studies. During my college years I served, with the approval of presbytery, a small but strong rural church. As a candidate under care of presbytery I needed help and the presbytery executive came at least every three months to serve communion and to guide me. This guidance continued through my seminary years.

As part of the old Synod of Kentucky I experienced the reality of divided Presbyterianism because both PCUS and UPC,USA were active in my state. Reunion and cooperation became a reality that sharpened my awareness of the effect of division. My seminary years were marked by the civil rights movement, the Vietnam Nam War and increased social ministry involvement. These forces shaped me and my ministry. Seminary was shaped by these forces and an era of changing leadership in the Church. The faculty went from retirement age professors to young persons who were under 40 years of age. I sometimes feel as though I came from two different eras. If what I have described were not enough it was also the time the church began to include women in ministry. All of these realities have shaped my life and ministry.

After many years of pastoral ministry I recognized that was receiving calls to churches that were not prepared to move on from their former pastors to new eras of ministry. An exploration into interim ministry training gave me keener insight into ways that intentional interim ministry might be a service to the church. Those insights and emphases have provided the impetus and focus of nine periods of interim ministry.

I have been out of active interim ministry for 16 months. During that time Janet and I have moved back to the upstate where're we are near our children and back to a presbytery where I previously served (John Knox).

Faith Statement of J. Lewis Johnson

Throughout my life there has been a strong sense that I and all humans are persons of value because we are children of God's creation. God has sought to establish a relationship with us. This God relationship has been enhanced by the presence in my life of Jesus Christ, who is Savior and Lord. This reality enriches all human interaction. For Christians this enrichment is often found most fully in the church, a community of faith and worship. Church exists for nurturing other persons of faith and for seeking out those persons who are in need of community. The church exists to serve her members and the world. There is an imperative to live out faith and to share it.

For me scriptures, the Bible, carry the weight of truth and for faith guidance. I believe that these scriptures are formative for me and hopefully others. It is imperative that we study these words in order to continue discovering the Word of life. We are compelled to use our minds to continually enlarge these creative words to reveal God's will and intention. We are to view these teachings as a dynamically powerful source of personal and community vitality. Scripture will show us the way to better, deeper relationships with all people of faith and those of unfaith as well.

Throughout history in times of conflict and need the Church has formulated documents to express particular theological positions. These have become our Book of Confessions. Herein we find a great breadth of expression that continues to fuel our theology and encourage us to talk of faith with sense, logic and clarity.

I have lived all my life in the shadow of the Presbyterian Church. I am pleased that my church is willing to wrestle with weighty subjects that confront us in our ever changing society. I expect us to be in this process. Even though I may at times be at odds with the final decision I recognize that there is collective wisdom in the living body of Christ. I am then required to listen to that collective wisdom.

There are many other specifics of my faith life. I believe that the above statement carries the broad scope of my present position.

STATEMENT OF CALL FOR HOLT ANDREWS

In the early spring of 2003 I was in my 11th year as Music Director at First Presbyterian Church in Spartanburg, SC. We were rather suddenly faced with an unusual situation...our Senior Pastor of only seven months abruptly resigned due to fallout in the congregation following a mission trip he was on. At the time, for various reasons, there were no full-time called pastors on the staff, and I was the longest-tenured professional staff member. I ended up writing the lead article for the first church newsletter following the resignation.

It was well-received by both those who felt the resignation was needed and those who did not. In a manner of speaking, for about two months until an interim minister was hired I was head of staff and (somewhat) the voice of the church. During this period I saw the congregation from a very different perspective, and had conversations and interactions that I had never had before. I began to wonder if there was more for me to do than serve as the Music Director. A choir member and elder suggested I look into becoming a CLP, which I did, but discovered that CLPs must be elders and as a staff member that did not seem appropriate. I continued as Music Director but with a new sense of restlessness about the remainder of my career. Was I being called to more, or to a different kind of work?

Fast-forward to 2010. Dr. David Renwick, our Senior Pastor at the time, proposed a way for me to renew my exploration of the CLP (now CRE) process. The church would ordain me as elder to fill a very brief unexpired term, and I would be replaced on the Session when a new class was ordained and installed. The Session agreed and I began my coursework. Because my Master's program in Sacred Music had included several classes at Vanderbilt Divinity School I received some exemptions. I did, however, profit greatly from my independent study with the late Dr. Bill Arthur in homiletics, the CPE program at Spartanburg Regional Hospital, and classes in Polity, Theology, and Church History at Dubuque Seminary.

Now I have completed all the requirements (save the examination) and am ready for my commissioning. My commission will look very similar to my current job description, at least initially. I am already a part of the church's pastoral care team, and preach and teach on occasion. Going forward, my new credentials may lead to my officiating at occasional weddings and funerals, as well as perform baptisms and lead communion as needed. I could also see a somewhat reduced list of musical duties replaced by more teaching and congregational care, again as needed.

I could also envision, after my time with FPC Spartanburg is done, assisting a smaller congregation in need of a pastor, and/or serving the presbytery in various (as yet unknown!) ways. I see the years to come as challenging ones for the PCUSA, as well as other mainline denominations; conversely, I also believe the message of the gospel and our way of communicating it will be needed more than ever. I look forward to finding ways to be a part of that process.

STATEMENT OF FAITH Raphael Holt Andrews

I believe that there is an "intelligent designer" of the universe, and that God, as the term is commonly understood, is the designer.

I stand in the Judeo-Christian-Islamic tradition in believing humanity on earth is a unique manifestation of God's creation, reflecting aspects of the divine.

I believe God's intention was that, while we would begin, in a manner of speaking, as little children of God, over time we would grow more into God's likeness and reflect a will that included humanity living together in peace and goodness.
