REDRESS OF IMBALANCE

The Book of Order (G-3.0301) requires the Presbytery to "adopt and communicate to the sessions a plan for determining how many ruling elders each session should elect as commissioners to Presbytery."

An examination of the total number of members of the congregations of the Presbytery and the total number of minister members reveals a ratio of 86 congregants for every minister member. Using each congregation's reported 2018 membership and assigning 1 ruling elder commissioner for every 86 members would lead to the following number of ruling elder commissioners for each Presbytery meeting. (Please note: This allocation caps the maximum number of ruling elder commissioners for all congregations of 1,500 or more at 15.)

Total Minister Members: 299 Total Congregation Membership: 25,716

*The newly formed **West Philadelphia Presbyterian Partnership** represents the 2019 collaboration of three churches: First African, Calvin ,and Good Shepherd. Because the redress of imbalance membership is determined by the 2018 year-end statistical report, each church is granted one elder commissioner per congregation.

This will be implementation beginning on December 1, 2019. This assigning begins in December 1, 2019 and continues through November 30, 2020.

Our stated meeting hosts will be reviewing each registered participant and grant access to the stated meeting, which will automatically be called to order at 10 a.m. *Note*: your video and audio feed will not be public and will remain *MUTED/OFF* while in waiting room *AND* for the duration of the meeting, except when invited to turn on and participate; these features are controlled by the meeting hosts so to assure security.

Guest Participants: If attending this virtual meeting as a guest and not as a commissioner or minister member, we ask that you note this in your pre-registration or when joining the meeting on the day of the event; NOTE: only commissioners and minister members are permitted to vote as a part of the meeting. Even a virtual meeting is an open and public gathering of the Presbytery of Philadelphia, thank you to all who join us! This meeting will also be broadcast on Facebook LIVE.

Other Important Information

I. Audio and Display

- A. Speaker View and Gallery View: Options are on the top right of yourscreen
 - 1. Speaker View:This view allows you to only view the individual who is talking during the stated meeting;
 - 2. Gallery View ("Brady Bunch"): This view shows all participants whose video is turned on; if more than allotted per screen, there will be multiple pages of participants able to be viewed and scrolled through on the center right and left of your screen; this view can enhance the connectional feeling in the midst of the meeting;
 - 3. On a mobile device, views can be changed by swiping right

- B. Participant Display Name: The name that appears on your screen cannot be changed once the meeting begins. This is a security feature. The name that appears is the name that is typed in at registration. Hosts of the meeting can change these names if necessary and appropriate.
- C. Audio and Video: All participants are MUTED. Only the audio of those who are leading the Stated Meeting and/or hosting the Stated Meeting will be turned on; should there be a request or need to hear from other participants hosts will unmute participants and request participants to turn on their video (if not already on). To do so, simply click share video on the bottom right of your tool bar or by clicking the video camera icon by your name in the participants window;

- **III. Voting and Deliberation**: *For this meeting, see asterisk at the end. There will several items that require action by commissioners and minister members of the presbytery and will be done so as follows:
 - A. Voting: Yes and No Options in Participant Window (NonverbalOptions)
 - 1. When acting on motions, the moderator will call for a vote. All those in favor will simply respond by visibly waving their hand ("jazz hands"). Make sure your video feed is on to do so.
 - 2. If voting by telephone, **to vote in favor, raise hand by dialing *9;** leave the hand raised until moderator instructs otherwise, then dial *9 again to lower hand; the moderator will the invite those discerning to vote "no" to raise their hand by dialing *9; leave the hand raised until moderator instructs otherwise, then dial *9 again to lowerhand
 - 3. We will not be using a voting ballot for this meeting. IF a ballot is called for in the case of a close vote, we will use the following process:
 - 4. If voting by telephone, to vote in favor, raise hand by dialing *9; leave the hand raised

until moderator instructs otherwise, then dial *9 again to lower hand; the moderator will the invite those discerning to vote "no" to raise their hand by dialing *9; leave the hand raised until moderator instructs otherwise, then dial *9 again to lowerhand

- Voting: Yes and No Options in Participant Window (Nonverbal Options): When acting on motions, the moderator will call for a vote. All those in favor please click click yes if in favor of the proposed action; click no if not in favor of the proposed. Votes are automatically tallied above the green and red, yes and no buttons. Votes can be changed/corrected; however, please adhere to the moderators instructions who will call for the end of the vote; once this occurs, please do not change your vote; the meeting hosts will "clear all" votes at the instruction of moderator
- If voting by telephone, to vote in favor, raise hand by dialing *9; leave the hand raised until moderator instructs otherwise, then dial *9 again to lower hand; the moderator will the invite those discerning to vote "no" to raise their hand by dialing *9; leave the hand raised until moderator instructs otherwise, then dial *9 again to lowerhand
- B. Questions: Raise Hand if you have a question pertaining to the proposed action
 - 1. On-Line: click the option to "raise hand"; all raised hands move to the top of the participant window in alphabetical order; moderator has privilege to recognize question or not; if recognized, audio will be turned on and video ask to be turned on; please address questions to the moderator; you can lower hand by clicking the same button that will now read "lower hand;"
 - 2. Phone: participants dial *9 and this raises hand and a hand is displayed next to your name on screen; If recognized, audio will be turned on; please address questions to the moderator; you can lower hand by once again dialing *9

IV. Breakout Groups

- A. The meeting will begin with worship and conclude with business. As part of worship, all participants/attendees will be invited to join a pre-assigned breakoutgroup:
 - 1. Once these groups go LIVE, you will see a window pop up on your screen requesting you to join the assigned breakout group, accept the invitation, ifdesired
 - 2. At this time, if desired, turn on your video and/or audio by selecting the video and audio buttons on your bottom toolbar *or* by clicking the video camera icon by your name in the participants window
 - breakout groups are timed and include passing of the peace and question to consideras
 part of sharing; time will appear at top right of your screen; once the group time is over
 you will be returned automatically to the main meeting and your video and audio will be
 OFF
- V. COMMISSION ON FINANCIAL MANAGEMENT

Please see the summary of the Presbytery's budget as of June 23, 2020.

Income

The top half of the table shows the Income portion of the budget and the year-to-date totals. Per Capita and Mission Giving are lagging to this point. This is likely due to the pandemic and the effects it's had on many of our churches. It should also be noted that these two sources of funding do not come in evenly throughout the year, so we hope our churches will be able to maintain their planned per capita and mission donations for the year.

Investment income is very low compared to the budget, but this is because the Presbytery has not felt the need yet to draw on this money. The Presbytery will draw upon the full, budgeted amount as needed during the year.

One unbudgeted source of funding for the operating budget is the Paycheck Protection Program (PPP) loan which the Presbytery applied for and received in early May. The total loan is for \$246,500, of which \$140,721 had been used at the time of this report to support staff salaries and benefit costs. Although this is a loan, we expect at least this amount to be forgiven and so it is being treated here as income. We know that some of our churches also applied for and received PPP loans. This has been a blessing to the Presbytery and our churches as they seek to keep staff on payroll. It will be a backstop to any loss in income caused by the shutdown.

The result for Income at this point shows total Income through June 23rd at 35% of total year's budget.

Expenses

With the pandemic, the Presbytery has made a concerted effort to reduce spending where it can. The Presbytery office has been effectively closed with staff working remotely. Thankfully, we have been able to retain and pay all staff at their full rate because of the PPP loan. Total expenditures to date have been only 38.6% of the budget.

Net Income minus Expense

The table shows a current budget deficit of over \$42,000. Because the Presbytery still hasn't taken the majority of its investment income, and because there is still money in the PPP loan (which we expect will be forgiven), we believe that the Presbytery's finances are in a reasonably good position at this point in the year. We still hope to have our churches submit per capita and mission giving payments, both of which will be very important to keeping the Presbytery on a sound financial footing.

Timothy Wotring Autobiographical Statement

My name is Timothy James Wotring. I was born and raised in Cumberland, Maryland, located in the Appalachian Mountain region. My parents own a flower shop and I have a younger brother. I have been part of the church for as long as I've been alive. In my teenage years, I played in a worship band and preached monthly at a nursing home. In 2008, I moved to Philadelphia to attend Eastern University. I received a BA in Theology four years later. After graduating, I worked at Broad Street Ministry with the Youth Initiative as a Spiritual Life Coordinator. I spent the next year as a youth pastor at Union United Methodist Church in Havertown until I matriculated into Union Theological Seminary in New York City in the fall of 2013. I wanted to attend a seminary that was known for creative experimental worship and liturgy, carrying out Christ's call for peace and justice, and high academic rigor.

After graduating from Union in 2016, I continued working in my field education placement at Broadway Presbyterian Church for four years total. I initiated and organized the volunteer program at the church's soup kitchen and shelter. I redesigned the organization's Supermarket Pantry and Clothing Distribution, and with the help of the pastor, created a monthly free dinner for the neighborhood. Moreover, in New York City, I was the Young Adult Volunteer Site Coordinator for two years, and the worship leader for Columbia University's campus ministry. Lastly, I started the Youth Engaging in Service summer ministry at Broadway Presbyterian Church. It lasted for three summers and 10 youth groups ended up attending my last summer there in 2018.

I moved back to Philadelphia in December 2018. I live with my cousin in Strawberry Mansion. I taught Sunday School for elementary school aged kids at Old Pine Presbyterian Church for several months. I worked at a homeless youth shelter for several months in Warminster, PA. Most recently, I worked with Pastor Sarah Colwill at Church on the Mall, helping with community outreach, social media, and technology. I also led a small faith community in Conshohocken called Church on the Bend; we started in June 2019 and met biweekly. In between all of that, I led worship for Bryn Mawr Presbyterian's youth group service.

Overall, my interests are wide, but mostly concern the well-being of those on the margins. For more than a decade, I have either worked for or volunteered at homelessness nonprofits. Likewise, I am a lifelong learner and completed the Church Planting and Revitalization Certificate Program at Pittsburgh Theological Seminary in September 2019. I am excited, God willing, to walk alongside Memorial Presbyterian as their pastor.

- Welcome Church: Coordination of a creative arts program alongside their neighbors experiencing homelessness.

WOODLAND PRESBYTERIAN CHURCH ADMINISTRATIVE COMMISSION REPORT TO THE PRESBYTERY OF PHILADELPHIA JULY 18, 2020 STATED MEETING

BACKGROUND

In the fall of 2016, the Woodland session indicated an interest in discussing the future of the church with the Commission on Ministry (COM). On October 20, 2016, Revs. Ruth Santana-Grace, (Executive Presbyter), Kevin Porter (Stated Clerk), Jonathan Speck, (Woodland, Stated Supply) and Linda Jaymes (COM liaison) met with the Woodland session at the Woodland Church.

During this meeting, the session shared their concerns about the future of the church. At this point, there were approximately 30 members. Yet, the commitment of this small church to its University City neighborhood was clear to all. For example, even now, through Woodland's partnership with Hands of Mercy Food Ministry, groceries are distributed weekly to those in need in the community. Woodland has also reached out and invited "the least of the brethren"—people whose behavioral norms are not usually welcome in traditional worship contexts. In addition, Woodland has used their property next door to the church to provide low-cost apartments for many international students from Penn and other nearby Universities. Some of these students came to know Christ through this ministry and a few became members of Woodland.

Woodland can actually trace this ministry back to 1925, when its Vacation Bible School included a group of foreign students. A number of these students made their first confession of faith in Jesus Christ in the Woodland Church, and later returned to their homelands to become leaders. One of them even became president of the Chiao Tung University in Shanghai, China.

Throughout its history, Woodland became widely known for its strong missionary spirit and support of missions. In 1870, one of the women of Woodland wrote a letter to the Presbytery proposing the formation of a Woman's Board of Foreign Missions, and as a result the Woman's Board of Foreign Missions of the Presbyterian Church was born. It's first president and corresponding secretary were also members of Woodland. And that's not all: Woodland Church was the first of all churches in the Presbytery of Philadelphia to organize a Woman's Home Missionary Auxiliary. That same year they undertook the support of a Miss Isabella Nassau in West Africa, being the first woman's organization in the country to assume that responsibility. By the early 1900's, more than a few of Woodland's own members became missionaries in India, Syria, China, Japan, Korea, Thailand, and Mexico. Some of these were medical missionaries and in 1900, one of these missionary couples became martyrs as a result of China's Boxer rebellion.

This hardly scratches the surface of Woodland's service to the Lord over its 155-year history. The challenge before us at that October 2016 meeting was how to best steward the deep love, commitment, and passion still held through this faithful remnant in a way that maximized the possibility Woodland's legacy would continue to bear fruit.

One of the possibilities that was suggested at this meeting was a creative partnership with City Church, an RCA congregation that was meeting in the West Catholic High School nearby. Woodland's session had had some interaction with this church a decade earlier when they seeking worship space. The

session welcomed the openness that the PC(USA)'s new form of government and the Presbytery leadership brought to this conversation. So, they agreed to reach out to City Church and the Presbytery agreed to appoint an Administrative Commission (AC) to work with them. This AC was appointed early in 2017; Rev. Linda Jaymes, as COM liaison was asked to be the chair, and the AC had its organizational meeting on March 29, 2017. The other AC members appointed were: Rev. Jade Bass (Minister at Large); Rev. Sandy Hull (Grace, Jenkintown); Elder Robert Kenworthy (Wallingford); Elder Brenda Tucker-Boykins (Bethel).

SUMMARY

At our first meeting, we were charged to "Walk alongside of the Woodland Presbyterian Church as they discern a future with the possibility of a joint ministry with the City Church of Philadelphia, a congregation of the Reformed Church in America." By this time, we were aware that Woodland had reached out to City Church, and so we contacted the Rev. Tuck Bartholomew, pastor of City Church, and Rev. Chris Currie, the associate pastor, to determine what steps they had taken with their congregation in regards to a possible partnership. At that point, little did we know that it would take 3 years to finish our work!

In September of 2017, with the encouragement of the Presbytery of Philadelphia, the Woodland congregation started the relational work of worshiping with City Church at the West Catholic High School location and strengthening the ties between the two congregations. They scheduled events that would help them get better connected and over time, they became eager to become one congregation.

Our committee had many, many meetings, sometimes with elders and/or pastors of City Church and our Executive and Stated Clerk often met with us as well. We explored the possibilities of a Union Church, Federated Church, the Broad Street Ministry model and various other configurations. In the end, none of these proved to be feasible given the complexities of the realities involved with two congregations with two denominational affiliations seeking to honor the joint ministry witness that was taking shape.

On February 12 of this year, with representation from all the stakeholders present, the proposal that follows was unanimously agreed upon. The addition of Elder Mike Henry, president of the Trustees of the Presbytery of Philadelphia, to the AC was invaluable in moving us forward. The Trustees endorsed this plan at their meeting on March 5. We believe that this recommendation achieves what the AC was commissioned to do. Although they will no longer be a part of our denomination your approval today will make it possible for the saints of the Woodland Presbyterian Church to build on the faithful legacy they started in University City in 1865.

WOODLAND PRESBYTERIAN CHURCH ADMINISTRATIVE COMMISSION RECOMMENDATIONS FOR PRESBYTERY APPROVAL

- 1. That the members of the Woodland Church will have their membership transferred to City Church. This was approved at a Woodland Session meeting on February 23, 2020.
- 2. That the Woodland ecclesiastical entity will be dissolved. This was approved by the Woodland congregation on February 23, 2020, subject (1) to its approval by the Presbytery of Philadelphia at its July 18, 2020 stated meeting and (2) approval of the final financial terms and disposition of assets between City Church and The Presbytery at the July 18, 2020 stated meeting.
- **3.** That the land parcel owned by Woodland Church at 401 S. 42nd Street, Philadelphia, PA, which contains the Sanctuary and attached Kirk Hall, along with a smaller structure known as the Fellowship Hall be sold to City Church for the sum of \$500,000 under the terms of the Agreement of Sale.
- **4.** Woodland has a second land parcel next to the parcel being sold to City Church. This smaller parcel has a house on it, called The Smythe House, located at 403 S. 42nd Street, Philadelphia, PA, which Woodland rents to international students at affordable rates as an outreach ministry. Since the Trustees do not wish to be a landlord, the Trustees have agreed that this property will be sold. That the Smythe House property be assumed by the Trustees of the Presbytery of Philadelphia upon the dissolution of the Woodland ecclesiastical entity to be held in trust and subsequently sold by the Trustees.
- 5. That \$100,000 of the Woodland Presbyterian Church's nearly \$700,000 in cash and securities assets (as of the end of 2019) be transferred to City Church to continue the historic mission work of the Woodland church.
- **6.** That two recent bequests made to Woodland by the Estate of Zarina Mandody and the Estate of Frances Benham be transferred upon receipt to City Church in recognition that those bequests were given to the Woodland Church mission/ministry for renovation of the Woodland Sanctuary/Kirk Hall.
- 7. That the Woodland organ fund of approximately \$80,778 gathered for the purpose of repairing/restoring the organ in the sanctuary be transferred to City Church to honor the donors who designated their contributions for this purpose.
- **8.** That the balance of funds inclusive of all cash assets including the proceeds of the sale of Smythe House not otherwise prescribed in the above actions or required for the maintenance of the Smythe House prior to its sale shall revert to the Presbytery of Philadelphia.
