	<b>Reports of all financial activities shall be made to session periodically and in no case less than annually.</b> G-3.0205		
	The <u>Annual Budget</u> * shall be included in the Minutes and approved by Session. At the Annual Meeting the congregation should be asked to receive the budget, and to approve the section dealing with the pastor's salary. G-1.0503c, G-3.0205		
	Compensation for all ordained and not-ordained staff shall be reviewed annually for adequacy and the amount of compensation approved shall be recorded in Minutes. G-2.0804, G-1.0503c, G-5.0505		
	Leases of any part of church property to outside groups <b>shall be approved by presbytery</b> . G-4.0101		
	Names of Ruling Elders, Deacons and Trustees who become ineligible for re-election. G-2.0404		
	The composition of the Session with regard to racial/ethnic members, women /men, and age groups and how this corresponds to the composition of the congregation. F-1.0403

The administration of the Sacrament of the Lord's Supper shall be recorded at the next regular meeting. When the Sacrament has been administered privately, the names of those assisting should be noted. G-3.0201b, W-2.4012		
Baptisms of adults and children shall be recorded at the next regular meeting. G-3.0201		
The <u>full names of applicants for church membership</u> shall be recorded: <u>Married females</u> - the maiden name, and wife or widow of.../ <u>Minors</u> (under the legal age of 18) - son or daughter of... G-3.0204a		
The name of the church from which persons are received by <u>certificate of transfer</u> shall be recorded and the full title of the church to which a certificate of transfer is granted and the full name of the person with the <u>date of dismissal</u> shall be recorded. G-3.0204a		
All <u>Congregational Meetings</u> shall be recorded in the Minutes Book. They may be approved at the next stated session meeting or by a committee and reported to Session. They shall be signed by the <u>Moderator and the Clerk</u> . G-1.0501		
All <u>marriages</u> --the place, date and time, names of contracting parties shall be recorded.		
All <u>deaths</u> --full name, date of death, place of burial shall be recorded.		
Miscellaneous exceptions.		
The minutes shall include a statement that the minutes of Session and register have been examined and reviewed by Presbytery.		
<b>It shall be reported in the minutes that all clergy and staff, and volunteers who work with children, have completed the required background checks and training to be in compliance with the Pennsylvania State Child Protection Laws. G-3.0108a; G-3.0202f</b>
