MINUTES OF THE 116th ANNUAL CONVENTION OF THE EPISCOPAL DIOCESE OF MONTANA BOZEMAN, MONTANA JULY 26, 27 & 28, 2019

The 116th Annual Convention of the Episcopal Diocese of Montana was called to order at 10:00 a.m. on Friday, July 26, 2019 by The Rev. Donna Gleaves, President of the Standing Committee, at the First Presbyterian Church in Bozeman, Montana. The Rev. Kristen Orr offered the opening blessing. The Rev. Canon Clark Sherman, Rector at St. James Church Bozeman was introduced. St. James is the host congregation for this Election Convention.

<u>Convention Committees</u>. The following individuals are serving on Convention committees:

<u>Credentials Committee</u>. Sandy Williams announced of a possible 66 clergy, 49 were registered and in attendance. 25 similar votes in the clergy order will constitute a majority. In the lay order, of a possible 111 lay members, 108 were registered and in attendance. The delegates in attendance (lay and clergy) constitute a two-thirds majority, therefore Donna Gleaves announced a quorum is present and the business of the Convention can proceed. Additionally, a majority vote in each order is required for the election of a Bishop, therefore, 25 clergy votes and 55 lay votes for one candidate will constitute a majority.

Adoption of Special Rules of Order for the Election of the Tenth Bishop of Montana. Diocesan Chancellor, Brad Foster, made a motion to suspend Title III, Canon 22, Rules of Order of the Constitution & Canons of The Episcopal Church, and to enact the Special Rules of Order for the Election of the Tenth Bishop of Montana. The motion was seconded, and approved by a vote of the Convention delegation.

<u>Appointment of Tellers for Election</u>. The Rev. Donna Gleaves announced the appointment of the individuals who will act as tellers for the election of the Tenth Bishop of Montana. All are from the Bishop Tuttle Deanery, and are currently sequestered in a separate room.

Election of Diocesan Secretary. The Rev. Randy Pendergraft, Chair of the Nominations Committee, announced Gayle Gallik Archey has been nominated as Diocesan Secretary. There being no further nominations for Secretary, upon motion made, seconded and approved, the nominations were closed. By motion duly made and seconded, Gayle Gallik Archey was unanimously elected to serve as Diocesan Secretary until the 2020 Diocesan Convention.

Proposed Amendment to Canons of the Diocese of Montana. Legislation Committee Chair, Rick Harden, introduced a proposed Substitute Resolution to Amend Canon 2, Section 2 (I) of the Canons of the Diocese of Montana to allow members of the Diocesan Council, members of the Standing Committee, Lay college chaplains, the Diocesan Youth Coordinator, the Diocesan Camp Director, and one youth from each Deanery, to vote in the election of Bishop of Montana. A motion was made and seconded to approve the Canon Amendment. Following a lengthy discussion with several suggested revisions to the Amendment, a vote of the convention delegation was taken. As this is a proposed change to the Canons, a separate vote on the initial motion from each order (clergy and lay) was taken, with at least ¾ of each order voting to approve the Amendment. As such, the new Canon 2, Section 2, entitled: Election and Election Procedure was amended to read as follows:

Canon 2, Section 2: Election and Election Procedure.

1. The Election of a Bishop shall be by a majority of both orders at the electing convention. The lay electors for the election of a Bishop shall be restricted to delegates elected to the convention from each congregation in the Diocese, all youth delegates to the electing conventions, and all clergy, in good standing, who are canonically and geographically resident to the Diocese.

<u>Eucharist Service for the Election of the Tenth Bishop of Montana</u>. Following balloting instructions given by Jill Sallin, the election process began with a Eucharist service. The

Rev. Jean Collins was Celebrant, and The Rev. Canon Bradley S. Wirth, Preacher. After passing the Peace, the balloting began.

<u>Election Business Announcement</u>. (1) The Rev. Donna Gleaves asked that after Communion, all lay delegates, voting clergy, and youth delegates sign a form circulated on clipboards prior to leaving the Church in order to certify the election and election results. (2) While delegates awaited Round 3 voting results, Donna Gleaves requested that no communication, to include digital, leave the Nave until all election processes were finished and finalized to include calling the newly elected Bishop. Donna noted she would call the newly elected Bishop to communicate her congratulations and anticipated the new Bishop would speak to the assembly by telephone speaker.

After reporting the results of Round 3 voting, a member of the clergy delegation moved that The Rev. Stebbins be accepted/approved as Montana's new Bishop by acclamation of the voting delegates. The motion passed unanimously.

The Rev. Donna Gleaves called The Rev. Marty Stebbins, congratulated her and asked if she accepted the election results, which The Rev. Stebbins did verbally and loudly. She voiced appreciation for the work of the Diocese during the application and nomination process, then provided a prayer of thankfulness and hope for a fruitful future in the Diocese.

Donna Gleaves left the Nave and voting delegation to privately call The Rev. Dr. Nina Ranadive Pooley to notify her of the election results.

With the election completed, Eucharist resumed. Following the conclusion of the Eucharist Service, the Convention was adjourned for the day.

<u>Convention Reconvened Saturday Morning</u>. The Convention reconvened at 8:00 a.m. on Saturday, July 27, 2019 with a Healing Eucharist at the GranTree Inn in Bozeman. The Rev. Canon Chris Roberts was Celebrant, and The Very Rev. Scott Anderson, Preacher.

<u>Business Session</u>. The Rev. Donna Gleaves called the business session to order at 9:30 a.m. The Rev. Terri Grotzinger offered the opening prayer. The Rev. Canon Clark Sherman announced raffle tickets were being sold for a hand-made quilt, with the proceeds to go to Camp Marshall. Barb Hagen in stated there is a variety of items: vestments, books, and various other items in the hall outside the Convention meeting room which came from churches that have closed. Barb encouraged everyone to look through the items and take any items that your church can use.

Report from Credentials Committee. Sandy Williams' updated Credentials Report indicated of a possible 52 clergy delegates, 47 were in attendance today, and of a possible 105 lay delegates, 102 were in attendance today. Sandy announced a quorum was present and the business of the Convention could proceed.

Standing Committee Report. Standing Committee President, The Rev. Donna Gleaves, introduced the members of the Standing Committee: Cynthia Benkelman, The Rev. Jean Collins, Rick Harden, Mary Messina, The Rev. Canon Bradley Wirth, and The Rev. Donna Gleaves. In their capacity as the Ecclesiastical Authority, the Standing Committee has met weekly since the 2018 Convention. They have addressed everything from the search for our next bishop to the everyday responsibilities of a bishop diocesan. Donna also introduced the Diocesan staff who have performed extraordinary work over

this past year: The Rev. Canon Chris Roberts, Barb Hagen, and Jill Sallin. The Camp Marshall staff includes: Sue LaRose, Mark Clemow and Paul Carlson-Thompson. Donna also recognized the members of the Nominating Committee, who brought a great slate of nominees. Members of the Nominating Committee were Keith Kuhn (chair), Laura Catlin, Mary Cavalier, The Rev. Stephen Day, The Rev. Steve DeHart, The Rev. Dorcie Dvarishkis, The Rev. Theresa Kelley, Nancy McManus, Hope Stockwell, Gretchen Swift, The Rev. Steven Yurosko, and The Rev. Bill Baumgarten (Chaplain). The Transition Committee was in charge of last year's send-off for the Brookharts, planned and executed the Walk-Abouts for the Bishop candidates, yesterday's election, and have already begun planning the Ordination and Consecration of our Bishop this December. Transition Committee members include: Gary Swartz and The Rev. Rick Johnson (cochairs), Doris Gerstner, Vicki Van Rensselaer, Darien Scott, Holly Swartz, Pat Sylvia, Jim Vorachek, Tom Wojtowick, Rich Winget and The Rev. Kristin Orr (Chaplain). Thanks were offered to all.

Bishop Waggoner, retired from the Diocese of Spokane, came to our Diocese in February to ordain The Rev. Gretchen Strohmaier and The Rev. Angelique Bolling. In May, the Standing Committee also arranged for Bishop Jessica Crist, of the Montana Synod, to confirm and receive a several people in Great Falls. Donna stated the Committee's full report is included in the Annual Report of the Diocese.

<u>Introduction of Bishop Jessica Crist</u>. Bishop Jessica Crist, from the Montana Lutheran Synod, was introduced. Bishop Crist stated the Lutherans have also elected a new Bishop this year. It has been 20 years since the Lutherans and Episcopalians voted to go into full communion.

<u>New Clerics to the Diocese</u>. The Rev. Canon J. Christopher Roberts, Canon to the Ordinary, introduced the following new clerics to the Diocese:

- 1. The Rev. Bryan Beveridge, St. Mark's Church in Big Timber.
- 2. The Rev. Bette March, St. Peter's Cathedral in Helena.
- 3. The Rev. Wells Warren, St. James' Church in Dillon.
- 4. The Rev. Jaime Leonard, Trinity Church in Ennis/Jeffers, and St. Paul's Church in Virginia City.
- 5. The Rev. Canon Dennis Campbell, St. Paul's Church in Hamilton.
- 6. The Rev. Gretchen Strohmaier, Holy Spirit Church in Missoula.
- 7. The Rev. Angelique Bolling, Holy Trinity Church in Troy.

<u>Rules of Order for the Convention</u>. The Convention will follow the General Convention Constitution and Canons, the Canons of the Episcopal Diocese of Montana, and the most recent edition of Robert's Rules of Order. The Rev. Donna Gleaves introduced

Brad Foster and Julianne Burkhardt, Chancellors of the Diocese, and George Kimmet, Parliamentarian. They will be available to offer advice on the Rules of Order throughout Convention.

Election of Diocesan Treasurer. The Rev. Randy Pendergraft, Chair of the Nominations Committee, announced Steven Yurosko has been nominated as Diocesan Treasurer. There being no further nominations for Treasurer, upon motion made, seconded and approved, the nominations were closed. By motion duly made and seconded, Steven Yurosko was unanimously elected to serve as Diocesan Treasurer until the 2020 Diocesan Convention.

<u>Committee on Legislation</u>. The Rev. Janis Hansen, Chair of the Legislation Committee, stated the Diocesan Office received one proposed Legislation to Amend Canon 16 Professional Standards, prior to the 60 day pre-Convention deadline. The proposed Amendment will be presented for consideration to the Convention delegation later today.

<u>Committee on Nominations</u>. The Rev. Randy Pendergraft, Chair of the Nominations Committee, stated nominations are being received to fill the following Diocesan positions. Elections will be held later in today's business session.

Diocesan Council. 2 lay people and 2 clerics, each for 3-year

terms.

Standing Committee. 1 lay person and 1 cleric, each for 3-year terms.

General Convention Deputies. 4 lay people and 4 clerics.

Committee on Resolutions. The Rev. Jean Collins, Chair of the Resolutions Committee, introduced 2 proposed Resolutions that were received prior to the 60 day pre-Convention deadline. (1) The first resolution would require the current members of Diocesan Council and the Standing Committee to continue to serve until December 31, 2019 for this year only. Those individuals elected today to Diocesan Council and Standing Committee will not take office until January 1, 2020. (2) The second resolution contains several proposed Constitutional Amendments from the National Church, which will be reviewed by the Convention delegation, and the final vote on the Constitutional Amendments occurring at the 80th General Convention in 2021.

<u>2020 Diocesan Operating Budget</u>. Diocesan Treasurer, The Rev. Steven Yurosko, and Canon for Finance, Barb Hagen, presented the proposed 2020 Operating Budget for the Diocese of Montana. The Budget is drafted by the Finance Department, and reviewed and revised by Diocesan Council. The budget is comprised of 3 separate budgets: Administrative, Program and Camp Marshall. The 2020 Budget is funded by a 19%

assessment, with the assessment calculation based on an average operating income of the Parish's parochial reports for the prior 3 years. It was noted that there is a reserve built into the 2020 budget, which will hopefully eliminate the need to draw money from investments. Upon motion duly made and seconded, the 2020 Diocesan Budget was received by a majority vote of the Convention delegation.

Election for Deputies to General Convention. Nominations Committee Chair, The Rev. Randy Pendergraft, announced the need to elect 4 clerics and 4 lay persons to serve as Deputies to General Convention in 2021. The nominees in the clergy order are: The Rev. Jean Collins, The Rev. Donna Gleaves, The Rev. Terri Grotzinger, the Rev. Connie Campbell-Pearson, and The Rev. Valerie Webster. The nominees in the lay order are: Cynthia Benkleman, Brad Foster, James Wiley and Sandy Williams. There being no further nominations in either the clergy or lay order, upon motion duly made and seconded, the nominations were closed. Ballots were cast by the Convention delegation with the following individuals being elected as Deputies to General Convention.

Clergy: The Rev. Terri Grotzinger, The Rev. Jean Collins, The Rev. Valerie

Webster, and The Rev. Donna Gleaves. The Rev. Connie Campbell

Pearson will serve as alternate.

Lay: Cynthia Benkelman, Brad Foster, James Wiley and Sandy Williams.

<u>Election for Diocesan Council.</u> The Rev. Randy Pendergraft announced the nominees to serve on Diocesan Council. 2 clerics are needed, each to serve a 3-year term. The nominees are The Rev. Stephen Day and The Rev. Jaime Leonard. There being no further nominations in the clergy order, upon motion duly made and seconded, the nominations were closed. Also, 2 lay persons are needed, each to serve a 3-year term. The lay nominees are Keith Kuhn, Mary Messina, Frank Pickett and Hope Stockwell. There being no further nominations in the lay order, upon motion duly made and seconded, the nominations were closed. In both the clergy and lay orders, ballots were cast by the Convention delegation with the following individuals being elected to Diocesan Council.

Clergy: The Rev. Stephen Day and The Rev. Jaime Leonard.

Lay: Hope Stockwell and Keith Kuhn.

<u>Election for Standing Committee</u>. 2 people need to be elected to the Standing Committee, one in the clergy order, and one in the lay order - each to serve a 3-year term. The Rev. Randy Pendergraft stated The Rev. Terri Grotzinger has been nominated in the clergy order, and Laura Catlin was nominated in the lay order. There being no further nominations in either order, upon motion duly made and seconded, the nominations were closed. A unanimous ballot was cast for The Rev. Terri Grotzinger and Laura Catlin each to serve a 3-year term on the Standing Committee.

<u>Thanks to Committee Members</u>. The Rev. Donna Gleaves offered thanks to those individuals who have served on various Diocesan boards, commissions, committees and councils, whose terms of service are expiring.

<u>Introduction of Guests and Announcements</u>.

1. Jane Anderson was introduced. She is the wife of The Very Rev. Scott Anderson, Dean of St. Peter's Cathedral. Jane will be hosting the Clergy Spouse's Luncheon today.

- 2. The Rev. Valerie Webster and The Rev. Janis Hansen will be hosting a Retreat at Camp Marshall on September 26 & 27, 2019.
- 3. The Montana Association of Church will be hosting an event in Bozeman on Saturday, October 12, 2019.
- 4. The Rev. Rev. Scott Anderson spoke of a trip he recently took to the Holy Land. Scott is planning another trip, and extends an invitation to anyone in the Diocese to join him. The date for the trip has not yet been selected, but a sign-up sheet is available for those interested.
- 5. The Rev. Marcia Lauzon gave an overview of the Verger Program, which is very active in our Diocese. Vergers help Clergy with logistics of the service. Marcia stated informational brochures are available to anyone interested in the program.

<u>Business Session Resumed</u>. Following a lunch break, The Rev. Donna Gleaves reconvened the business session at 1:30 p.m., with prayer lead by The Rev. Terri Grotzinger.

<u>Committee on Legislation</u>. Committee on Legislation Chair, The Rev. Janis Hansen, stated one proposed legislation has been submitted to Convention.

1. Amend Canon 16 of the Diocesan Canons - Professional Standards. This amendment is proposed by the Standing Committee. While the Diocese has policy for Professional Standards, in order for clergy, in particular, to be held accountable for

compliance with criminal background checks and safeguarding training, it should be part of canon law. Upon motion duly made and seconded, it was agreed by a ¾ majority vote by orders (clergy and lay), to amend Canon 16 of the Diocesan Canons entitled Professional Standards, as follows:

CANON 16 - PROFSSIONAL STANDARDS. Clergy, licensed lay ministers, and professional employees shall conform to the highest professional standards. Those standards shall include, but not be limited to, those outlined in the Canons of the General Convention.

Section 1. All clergy, active and retired, in order to retain licensure to function within this Diocese, shall have to pass a criminal background check and complete safeguarding against abuse and harassment training every four years. Congregations in which the clergy serve shall pay the expense of this requirement. In the event the clergy person is not affiliated with a congregation, the Diocese shall pay the expense of this requirement.

Section 2. All clergy, from outside the diocese, elected or appointed to clerical positions within the Diocese, shall show current evidence of both criminal background checks and safeguarding against abuse and harassment training, prior to receiving licensure. The Ecclesiastical Authority shall determine if the training received, and the criminal background check, in the previous diocese, is sufficient.

Section 3. All laity, if serving in a ministerial capacity requiring criminal background checks and completion of safeguarding against abuse and harassment training, shall renew the same, every four years. The congregations in which they serve shall be responsible for meeting the expense of such background checks. For laity serving in a diocesan capacity, the Diocese shall be responsible for meeting the expense of such background checks.

Section 4. It shall be the responsibility of the Ecclesiastical Authority, in consultation with the Commission on Ministry, to determine the nature of the criminal background check and the safeguarding education.

Section 5. It shall be the responsibility of the Diocese of Montana to maintain records of compliance with the above sections of Canon 16.

<u>Committee on Resolutions.</u> Committee on Resolutions Chair, The Rev. Jean Collins, stated one proposed resolution has been submitted, and also proposed General Convention Resolutions.

1. Resolution to Extend Retiring Current Standing Committee and Diocesan Council Membership until December 31, 2019. This Resolution is proposed by the Standing Committee for the sake of continuity of the Ecclesiastical Authority of the Diocese during our time of transition until the Bishop Diocesan is ordained on December 7, 2019. Upon motion duly made and seconded, the following Resolution was approved by the Convention delegation:

BE IT RESOLVED: That the membership of the Standing Committee and the Diocesan Council, as they are currently comprised, be allowed to continue in office until December 31, 2019.

It was noted that newly elected Standing Committee members and Diocesan Council members will be allowed to attend their respective meetings between now through December 31, 2019, but members will not have voice or vote at said meetings.

2. Resolutions Referred to Dioceses From the 79th General Convention of the National Church. The Convention Delegation reviewed a list of proposed Constitutional Amendments which will be voted on at the 80th General Convention in 2021. This list is for informational purposes. No action is required by the Diocese.

<u>United Thank Offering Report</u>. Vicki Van Rensselaer, Diocesan United Thank Offering (UTO) Coordinator, spoke of the work of UTO. The Convention delegation contributed money to UTO by filling UTO in-gathering boxes. Since its inception, UTO has given the Diocese of Montana 19 grants, including \$55,000.00 for a new septic system at Camp Marshall.

<u>Deacon's Report</u>. A report on the Deaconate Order was given by The Venerable Roxanne Klingensmith, Archdeacon. Roxanne acknowledged all deacons serving in the Diocese, and thanked them for their work. Special thanks were offered to those deacons actively engaged in the Bishop search and transition: The Rev. Donna Gleaves, The Rev. Steve Dehart, The Rev. Dorcie Dvarishkis, and The Rev. Rick Johnson. Roxanne congratulated The Rev. Connie Campbell-Pearson as recipient of the Stephen Recognition Award. Roxanne acknowledged the faculty of the School for Deacons and thanked them for their dedication and commitment to training our deacons in Montana.

Report of Ecumenical Development and Inter-Religious Officer. The Rev. Valerie Webster spoke of her duties as the Diocesan Ecumenical Development and Inter-Religious Officer, and also of her work with the Montana Association of Christians. Valerie talked about her experiences doing prayer and ministry throughout the Diocese by helping with food banks, wood banks, shelters and with the homeless.

Report of Disaster Coordinator. The Rev. Mary Alice Jones spoke about the work of Episcopal Relief and Development (ERD) and the tools and resources ERD has available to assist our Diocese with disaster preparedness. Mary Alice mentioned Asset Mapping, which is knowing what assets a church has available, and what the parishioners can do with those assets to help with the needs in their community. Asset Mapping provides an opportunity to take action to affirm the worth of the people in the Church, and empower them to see themselves as part of a greater community. Mary Alice and her husband, The Rev. Jim Jones, are available to come to your Church and teach the congregation about Asset Mapping.

<u>Solar Panels at St. James in Bozeman</u>. Susan Foster, parishioner at St. James in Bozeman, has been working with Northwestern Energy for the installation of solar panels on the roof of St. James Church. Northwestern Energy has a grant program for solar panels for churches, and also a grant program for LED light bulbs and fixtures. Susan encouraged other churches to consider these programs for their church buildings. It was noted that St. James Church in Lewistown installed solar panels on their roof last year.

<u>Annual Diocesan Report</u>. Upon motion duly made and seconded, it was unanimously agreed to accept the 2018 Annual Report of the Diocese, which is posted in its entirety on the Diocesan website.

<u>Courtesy Resolutions</u>. Members of the Resolutions Committee offered the following Courtesy Resolutions:

Whereas, members of St. James Bozeman have welcomed us to the 116th Convention of the Diocese of Montana and the election convention, with special thanks to the Convention Committee Chair, Tricia Bailey and Ben Scallon, and the Transition Committee members, especially Vicki Van Rensselaer and Rich Winget for their patience and their tireless work coordinating both an election convention and diocesan convention.

Episcopal Diocese of Montana Minutes of Diocesan Council Conference Call January 26, 2019

The Diocesan Council of the Episcopal Diocese of Montana held its quarterly meeting via conference call, beginning at 10:00 a.m. on Saturday, January 26, 2019.

Attendance. Council members participating were: George Kimmet, Sandy Williams, Cynthia Hoelscher, The Rev. Janis Hansen, The Rev. Randy Pendergraft, The Rev. Dorcie Dvarishkis, Jerry Southwood, The Rev. Canon Clark Sherman and Cathy Morris. Council members The Rev. Richard Reynolds, The Rev. Joan Yetter and Manny Hoag were absent. Also participating in the call were: Barb Hagen, Canon for Administration and Finance; The Rev. Steven Yurosko, Diocesan Treasurer; Gayle Gallik Archey, Diocesan Secretary; and The Rev. Jean Collins, Liaison from the Standing Committee.

Call to Order. Vice President, The Rev. Janis Hansen, began the conference call with prayer. With a quorum participating, the conference call meeting was called to order. The agenda, previously distributed via email, was accepted as printed.

Requests from Churches - 2019 Assessment. Representatives from St. Mark's Anaconda, St. Mark's Big Timber, St. Paul's Fort Benton, St. Paul's Hamilton and St. Paul's Virginia City also joined the conference call to request specific consideration with respect to the calculation of their respective parish's 2019 monthly Assessment payment.

St. Mark's Anaconda. Terry Montgomery and The Rev. Theresa Kelley request the monthly assessment payment for St. Mark's be reduced to \$375.00, instead of the calculated \$500.00(+). Due to an accounting error on their parochial report, the proposed 2019 monthly assessment payment does not accurately reflect the Parish's income. Additionally, over the past 7 years, St. Mark's has drawn down its investment account by 60% in order to pay operating expenses.

St. Mark's Big Timber. On behalf of St. Mark's Big Timber, Jami Moody, Jill Brown, Sandy Blake, John Horton and Sarah Gregie voiced their concern of the 2019 assessment calculation, which is nearly double what the Parish paid in 2018. They feel this increase is entirely out of proportion and unjustified. The Church is in the process of calling a new priest, and anticipate a \$32,000 loss in 2019.

St. Paul's Fort Benton. On behalf of their Parish, Sue Lepley and Gail Good request the 2019 monthly assessment payment remain the same as last year. St. Paul's has only 3 families that support the Church, with an endowment fund being used to pay for building maintenance.

St. Paul's Hamilton. Jocelyn Snider, Sr. Warden, requests a reduction to St. Paul's projected 2019 monthly assessment payment. They need the money to pay The Rev. Dennis Campbell, a new supply Priest who will hopefully serve their Parish. Jocelyn mentioned St. Paul's has only 17 pledging units for 2019.

St. Paul's Virginia City. Jaime Leonard and Janet Doornbos stated the income reported on the parochial reports of St. Paul's include extra money received from investments and insurance claims, and does not accurately reflect the Church's average income. Therefore, it is not possible for St. Paul's to pay the projected \$1,059.00 monthly assessment payment in 2019, as some months, they don't collect this much money the entire month. On behalf of the Vestry, they request the monthly assessment payment for 2019 remain the same amount as in 2018.

<u>St. James Dillon</u>. Although not participating in the call, Kay Roach, a representative from St. James, sent an email to the Diocesan office stating the Parish will continue to pay 19% of the prior month's income for their monthly assessment payment, instead of switching to the 2019 calculation formula.

Before all representatives from Anaconda, Big Timber, Fort Benton, Hamilton and Virginia City disconnected from the conference call, Council members thanked them for taking the time to call and share the concerns of their Churches.

Following discussion, it was agreed that Dorcie Dvarishkis will draft letters to the five above-referenced Parishes, requesting they provide Council with adjustments to their parochial report operating income, and/or a proposed monthly assessment payment amount for 2019. Clark Sherman will help with the letter to Hamilton, and Janis Hanson will assist with the letter to Fort Benton. Janis Hansen stated there is a need for organizational development with Churches having problems, and the Diocese should take a more pastoral role helping Churches in need.

OLD BUSINESS.

Minutes of November 3, 2018 Conference Call. The following revisions were made:

Paragraph entitled "<u>Updates to 2019 Camp Marshall Budget</u>." The second paragraph was revised as follows: Council members reviewed a proposal submitted by Sue LaRose, Director of Camp Marshall. Sue brought forth a proposal to offer a bonus to the Site Manager in October 2018. Upon motion duly made and seconded, the proposal was unanimously approved.

Paragraph entitled "<u>Update to 2019 Diocesan Operating Budget</u>," was revised as follows: Council discussed a request from E.F.M. in Missoula to reinstate the \$1,750 line item for E.F.M. back into the 2019 Diocesan Budget. E.F.M. plans to explore options in the coming year. Upon motion duly made and seconded, Council agreed to reinstate the \$1,750 line item in the 2019 Diocesan Budget for E.F.M.

Upon motion duly made and seconded, the Minutes of the November 3, 2018 Diocesan Council conference call were approved as revised.

Financial Reports. Diocesan Treasurer, The Rev. Steven Yurosko, and Canon for Finance, Barb Hagen, presented the December 2018 financial statements. Barb stated the Diocese suffered large losses in investments. The following Camp Marshall funds: dock funds, Brookhart scholarship funds, bathhouse funds, and capital campaign funds, have been moved to a minimal risk fund (Short term bond fund). Upon motion duly made and seconded, the December 2018 financial reports were approved as presented.

Acceptance of Finance Department Minutes. Upon motion duly made and seconded, Council members acknowledged receipt of the Department of Finance meeting Minutes from June 19, 2018 and from January 15, 2019.

Parish Audit Report Update. 2017 Parish Audit Reports have been received from all parishes with the exception of Great Falls. Barb Hagen spoke with the Treasurer at Incarnation, who requested Incarnation be allowed to submit their 2017 and 2018 Audits at the same time. Janis Hansen will write a letter to Incarnation suggesting they present a formal request to Council to submit their 2017 and 2018 Audits to the Diocese at the same time.

Sale of Church Building in Glasgow. The Glasgow Church building sold on December 19, 2018 for \$97,548.39. The sales proceeds were placed in the Faber Fund Account. Barb Hagen stated there has been some interest in the farmland, which is still for sale.

Diocesan Website. Cynthia Hoelscher and Janis Hansen stated the Diocesan Website needs a lot of work to bring it up to date. They will continue their work and provide progress reports to Council.

Update - 2018 Additional Assessment. Dorcie Dvarishkis will draft a letter of thanks to all Parishes who paid the additional assessment in 2018. Dorcie will provide Council members with a draft of the letter before she sends it out.

Camp Marshall Site Manager. The Camp Marshall Site Manager has declined the bonus she was offered. Clark Sherman will draft a letter thanking her for all her service to the Camp.

NEW BUSINESS.

Report of the Standing Committee. The Rev. Jean Collins, Liaison from the Standing Committee to Diocesan Council, gave a update on the work of the Standing Committee, who is meeting weekly via phone and monthly in person.

- (1) The Committee has drafted Guidelines for Reimbursement of Expenses for all committee members, staff travel and General Convention Deputies. The Guidelines have been approved by the Finance Department, and will next be presented to Diocesan Council for consideration.
- (2) The Diocese has received an offer from LoneTree Energy & Associates, LLC to lease the mineral interests in Divide County, North Dakota that was previously owned by St. Matthews Church in Glendive, and is now owned by the Episcopal Diocese of Montana. LoneTree would like to lease the minerals on the real property with the intent to drill oil and/or natural gas wells. The Standing Committee unanimously opposes leasing the mineral interests for the purpose of oil and gas exploration. Upon motion made and seconded, Council members agreed to reject the current Lease offer the Diocese received from LoneTree Energy & Associates.
- (3) The Standing Committee has been working on issues related to Title IV.
- (4) Barb Hagen has drafted a document which outlines the responsibilities of the Diocesan Council and the responsibilities of the Standing Committee, expectations of each, and how they can work together.

General Convention Resolutions. Council members will review the 79th General Convention proposed Resolutions with changes to the Constitution at their March 16, 2019 meeting.

Venture In Mission Grant Report. Upon motion duly made and seconded, Council members acknowledged receipt of a Statement of Grant Accounting from St. James Church in Dillon for the \$1,700.00 Venture in Mission Grant they received. St. James used \$1,383.70, and therefore has returned the balance of \$316.30 to the Diocesan office.

Vickers' Fund Grant Reports. Upon motion duly made and seconded, Council members acknowledged receipt of the following Statement of Grant Accountings for Vicker's Fund Grants:

- 1. Statement from The Rev. Steven Yurosko for the \$1,350.00 grant to attend the College of Congregational Development in June 2018;
- 2. Statement from St. James Church in Lewistown for the \$13,450.00 grant they received for the Heart of Montana Youth Choir. St. James still retains \$3,906.89 of the grant money.
- 3. Statement from St. Stephen's Church in Billings for \$50,000.00.
- 4. Statement from The Ven. Roxanne Klingensmith for the \$4,947.00 grant for the Gathering of Deacons held in Helena on May 18-20, 2018. \$4,918.48 was used, leaving a balance of \$28.52.

Closure of St. Paul's of the Stillwater Church in Absarokee. Council members reviewed a letter dated October 2018, addressed to the Standing Committee from St. Paul's of the Stillwater in Absarokee. St. Paul's requests the Church be closed due to lack of membership. The Church is now closed. A motion was made, seconded and approved by a majority of vote to accept St. Paul's request for closure.

St. Mark's Church in Havre. St. Mark's in Havre has requested closure. In past years, Havre has received an annual grant which enabled them to pay operating expenses. This year, they did not get the grant money. The Standing Committee is working with the parishioners to hopefully keep the Church open. The Diocese has offered to pay their bills and give them a retro-active Faber Fund grant to replace the furnace. The Rev. Canon Bradley Wirth, and The Rev. Jean Collins will meet with the parishioners on February 15-16, 2019. Upon motion duly made and seconded, it was agreed that Council will support the Standing Committee's recommendations for St. Mark's Havre, and will review this matter again at Council's March 16, 2019 meeting.

Updates to Guidebooks and Manuals. Upon motion duly made and seconded, Council members unanimously approved various revisions to the Sr. Warden, Jr. Warden, Clerks & Treasurers Handbook, the Church Treasurer's Guidebook, and the Accounting Policy and Procedure Manual, as recommended by the Finance Department.

Grant request from Gethsemane Church in Manhattan. In October 2018, Gethsemane Church made application for a Faber Fund Grant in the amount of \$2,250.00, to purchase a new pipe organ for the Church. The Rev. Canon Clark Sherman announced that Gethsemane wishes to withdraw the Application, as they no longer need the money. They have raised the total amount needed to purchase the organ.

Audit Information on Diocesan Website. Barb Hagen stated Churches can now file their Audit Reports on-line. Barb is hopeful this added convenience will help with compliance.

Assessment Payments - St. James Dillon. St. James has notified the Diocesan office that they will continue to base their monthly assessment payment on 19% of the prior month's income. As St. James recently called a new priest, it was suggested to have a conversation with the new priest, but to wait a period of time until the new priest gets settled. The Rev. Janis Hansen offered to talk with the new Priest at St. James.

Phone System Update. Barb Hagen stated the phone system at the Diocesan Office is 11 years old and is failing. The proposal for a new phone system is \$2,705.00. Finance Department has approved this expense - taking money from the equipment reserve fund which currently has a balance of \$3,013.00. Upon motion duly made and seconded, the proposal for a new phone system for the Diocesan Office was approved.

Bishop's Search and Transition Expenses. The Transition Committee has requested another \$9,350.00 to cover expenses associated with the Bishop's Search process. This money will have to come from the endowment funds. Upon motion made and seconded, it was agreed to table this request until Council's March 16, 2019 meeting.

Additionally, \$2,500.00 is needed to pay an honorarium and travel expenses for Bishop Waggoner from Spokane, who will come to Montana to perform two ordinations. Upon motion made and seconded, Council members approved this request to pay Bishop Waggoner for his service to the Diocese of Montana.

Additional Funding for General Convention Deputies. Barb Hagen has been directed by the Standing Committee to find funds to reimburse \$221.76 to a deputy to General Convention whose expenses exceeded the allotted amount. Upon motion duly made and seconded, it was agreed to approve this expense and reimburse the General Convention deputy.

Future Diocesan Council Meetings. It was suggested that Council meet more often, especially in this year of transition. Therefore, Council will conduct a **conference call meeting on Thursday, February 14, 2019 at 7:00 p.m.**Additionally, 2019 meetings of the Diocesan Council are scheduled as follows:

Saturday, March 16, 2019 (in-person) to be held at St. James Church in

Bozeman.

Saturday, May 18, 2019 (in-person) to be held at St. Peter's Cathedral in Helena.

Saturday, November 2, 2019 (conference call).

Conference calls begin at 10:00 a.m. In-person meetings are from 10:00 a.m. to 3:00 p.m.

Adjournment. There being no further business to come before the Diocesan Council, on motion duly made and seconded, the conference call was adjourned by Vice President, The Rev. Janis Hansen at 12:45 p.m.

The Diocesan Council of the Episcopal Diocese of Montana held its quarterly meeting via conference call, beginning at 7:05 p.m. on Thursday, February 14, 2019.

Attendance. Council members participating were: Sandy Williams, Cynthia Hoelscher, The Rev. Janis Hansen, The Rev. Randy Pendergraft, Manny Hoag, The Rev. Dorcie Dvarishkis, Jerry Southwood, The Rev. Canon Clark Sherman and Cathy Morris. Council members The Rev. Richard Reynolds, George Kimmet and The Rev. Steven Yurosko, Diocesan Treasurer, were absent. Also participating in the call were: Barb

Hagen, Canon for Administration and Finance; Gayle Gallik Archey, Diocesan Secretary; and The Rev. Jean Collins, Liaison from the Standing Committee. It was noted The Rev. Joan Yetter has resigned from Diocesan Council.

Call to Order. Vice President, The Rev. Janis Hansen, began the conference call with prayer. With a quorum participating, the conference call meeting was called to order. The agenda, previously distributed via email, was accepted as amended.

OLD BUSINESS.

Minutes of January 26, 2919 Conference Call. The paragraph of the Minutes entitled "<u>Sale of Church Building in Glasgow,"</u> was corrected to reflect the church building was sold on December 19, 2018. Upon motion duly made and seconded, the Minutes of the January 26, 2019 Diocesan Council conference call were approved as revised.

Diocesan Website. Cynthia Hoelscher stated the results of a survey taken about the Diocesan Website indicates the website is not well used, other than to access information about Convention and Camp Marshall. Other items are hard to find on the website, and remote access is usable but awkward. Upon motion duly made and seconded, it was agreed to hold off on the website update until our new Bishop is in place.

Responses to Churches Requesting Lower Assessments in 2019.

<u>St. Mark's Anaconda</u>. Upon motion duly made and seconded, it was agreed to accept the proposal from St. Mark's Anaconda to pay a monthly assessment of \$375.00 for 2019. Dorcie and Clark will draft a letter letting them know their request has been approved.

St. Mark's Big Timber. A motion was made, seconded and approved to allow St. Mark's Big Timber to pay the same monthly assessment amount in 2019 as they did in 2018, until a visitation can be made to the Church to gather more information and talk to parishioners. Dorcie will write a letter to St. Mark's. Additionally, Janis and Sandy will plan a visit to the Church.

St. Paul's Fort Benton. Upon motion made and seconded, St. Paul's Fort Benton request was granted to allow them to pay \$945.00 for 2019, which is the same assessment amount they paid in 2018. Dorcie will draft a letter advising the Church that their request has been approved. Also, Dorcie plans to visit the parish.

St. Paul's Hamilton. A motion was passed to approve the request of St. Paul's Hamilton to reduce their 2019 Diocesan Assessment by \$6,000.00. Dorcie and Clark will work together to draft a letter to St. Paul's to let them know their request has been approved.

St. Paul's Virginia City. Upon motion made and seconded it was agreed to allow St. Paul's Virginia City to pay the same assessment amount in 2019 as they did in 2018. Dorcie will write a letter to St. Paul's, and Janis plans to visit the Church and talk with the parishioners.

Report of the Standing Committee. The Rev. Jean Collins, Liaison from the Standing Committee to Diocesan Council, gave an update on the work of the Standing Committee. The Standing Committee is meeting weekly via Google Hangout, and once a month in person in Helena. Jean stated better communication between Janis and the Diocesan Council, and Donna and the Standing Committee would be very helpful during this time of transition.

- (1) The Rev. Canon Bradley Wirth and the Rev. Jean Collins will go to Havre on Friday and Saturday (2/15-16/2019) to meet with the members of St. Mark's to discuss the future of their Church.
- (2) The Committee continues to work with the Rev. Canon Chris Roberts on the congregational search process for clergy in our Diocese, so to align it with the General Church Canons.
- (3) On February 5, 2019, a letter was drafted to all congregations of the Diocese to discuss a resolution that was approved at General Convention last summer. The resolution is for a 3-year suspension on the Canon that places a time limit on initiating proceeding in cases of clergy misconduct against adults. The Standing Committee requests the letter be printed and posted in a public place in all our congregations. In addition, a new poster has been designed for churches to post entitled "Harassment and Pastoral Relationship What you should know about harassment in a church setting."
- (4) The Rev. Carolyn Rosen has been elected and is serving as Rector at St. Stephen's in Billings, as the Rev. Joan Yetter has retired.

Oil and Gas Lease. Janis Hansen stated she has obtained additional information on the offer from LoneTree Energy & Associates, LLC to lease the mineral interests in Divide County, North Dakota previously owned by St. Matthews Church in Glendive. With the closure of St. Matthews, the mineral interests are now owned by the Episcopal Diocese of Montana. Janis stated this is a private lease, not through the

Bureau of Land Management. The Diocese owns the mineral interests on 160 acres, but does not own the real property. Janis stated her research on this continues, and she will report back to Council when she learns more.

NEW BUSINESS.

Faber Fund Grant Application - St. Mark's Havre. Council members reviewed an Application for Faber Fund Grant from St. Mark's in Havre, for the repair of the Church furnace. St. Mark's is requesting \$1,341,50, and the Finance Department recommends approval of the Application. Upon motion duly made and seconded, it was unanimously agreed to approve the Faber Fund Grant to St. Mark's Havre.

Faber Fund Grant/Loan Application from St. James Bozeman. St. James Bozeman has submitted a Faber Fund Application for \$10,000.00 to upgrade the Church organ, the organ pipes and related carpentry work. The total cost of the project is estimated at \$48,000.00 to \$53,000.00. It was noted a requirement of the application process is that the church must have raised 33% of the funds prior to making application. Upon motion duly made and seconded, it was agreed to defer acting on this request until St. James Bozeman can confirm they have already raised 33% of the funds. Council will revisit this matter at their March 16, 2019 meeting.

It was agreed to defer acting on this request until Council's March 16, 2019 meeting, at which time additional information should be available to make a decision.

Expense Reimbursement Guidelines - 2019. Council members reviewed proposed Expense Reimbursement Guidelines for 2019, which has been approved by Finance Department and the Standing Committee. It was decided to defer this matter and discuss it in-person at Council's meeting on March 16, 2019.

Episcopal Diocese of Montana Minutes of Diocesan Council Meeting March 16, 2019

The Diocesan Council of the Episcopal Diocese of Montana held its quarterly meeting at St. Peter's Cathedral in Helena, beginning at 10:00 a.m. on Saturday, March 16, 2019.

Attendance. Council members present were: Sandy Williams, Cynthia Hoelscher, The Rev. Janis Hansen, The Rev. Dorcie Dvarishkis, George Kimmet, Manny Hoag, Jerry Southwood and Cathy Morris. Council members The Rev. Randy Pendergraft, and The Rev. Canon Clark Sherman were absent. The Rev. Richard Reynolds, and The Rev. Joan Yetter have both resigned from Diocesan Council. Also in attendance were The Rev. Steven Yurosko, Diocesan Treasurer; Barb Hagen, Canon for Administration and Finance; Gayle Gallik Archey, Diocesan Secretary; and The Rev. Jean Collins, Liaison from the Standing Committee.

Call to Order / Adoption of Agenda. With a quorum in attendance, Vice President, The Rev. Janis Hansen, called the meeting to order. Janis opened the meeting with prayer. The agenda was distributed and accepted as presented. As this was Council's first in-person meeting of the year, Council members took a few minutes to introduce themselves to one other.

OLD BUSINESS.

Minutes of February 14, 2019 Conference Call. Upon motion duly made and seconded, the Minutes of the February 14, 2019 Diocesan Council conference call were approved as presented.

Financial Reports. Barb Hagen and The Rev. Steven Yurosko presented the financial statements as of February 28, 2019. Barb stated investments are doing well, and cash flow is good. The new assessment process has been a fairly smooth transition.

Most churches are paying their full amount. Steven Yurosko thanked Council members for helping the churches with this process. Upon motion duly made and seconded, it was unanimously agreed to accept the February 28, 2019 Diocesan financial reports.

Brandon Costley from RBC Wealth Management. Barb Hagen announced that Brandon Costley, Financial Consultant with RBC Wealth Management is unable to join us today, but will give his presentation at Council's May 18th meeting.

Acceptance of Finance Department Minutes. Upon motion duly made and seconded, Council members acknowledged receipt of the Department of Finance meeting Minutes of March 11, 2019.

Parish Audit Report Update. All churches have submitted their 2017 Parish Audit Reports to the Diocesan office with the exception of Incarnation in Great Falls. The Rev. Janis Hansen will call Incarnation to discuss their past due audit report.

Oil and Gas Lease Information. The Rev. Janis Hansen stated her work continues to obtain information on the mineral interests in Divide County, North Dakota, previously owned by St. Matthews Church in Glendive, and with the closure of St. Matthews, said mineral interests are now owned by the Episcopal Diocese of Montana. Janis has contacted several individuals and agencies, and is waiting for return calls. It was suggested to contact Ralph Spence, a former member of St. Stephens in Billings, as he is very familiar with oil, gas and mineral leases. Also, it was suggested to contact The Rev. Michael Fay, former Rector at St. Matthews in Glasgow, to see if he has any information on the mineral interests.

Faber Fund Grant Application from St. James Bozeman. St. James Bozeman submitted a Faber Fund Application to Council in February 2019, requesting \$10,000.00 to upgrade the Church organ, the organ pipes and related carpentry work. The total cost of the project is estimated at \$48,000.00 to \$53,000.00. Council deferred acting on this request until St. James confirmed that the Parish had already raised 33% of the requested funds, which has now been done. Upon motion duly made and seconded, it was agreed to approve this grant request.

Bishop's Search and Transition Expenses. At their February 2019 meeting, Council considered a request from the Transition Committee for additional monies to cover expenses associated with the Bishop's Search process. At that time, Council agreed to defer this matter pending additional information, which now has been received. The Transition Committee is seeking an additional \$11,300.00, to be used for candidate "walk-about" expenses, which were not included in the initial budget. Upon motion duly made and seconded, it was agreed to support the Search Committee and

approve the additional \$11,300.00, with the caveat to be mindful of incurring additional expenses.

NEW BUSINESS.

Report of the Standing Committee. The Rev. Jean Collins, Liaison from the Standing Committee to Diocesan Council, gave an update on the work of the Standing Committee. The Committee continues to meet weekly via Google Hangout, and once a month in person in Helena.

- (1) The Rev. Canon Bradley Wirth and The Rev. Jean Collins went to Havre on Friday and Saturday (2/15-16/2019) and met with 5 members of St. Mark's. There are approx. 10 members total with the rest snow-birding in the south. After 10 years without a priest, they are exhausted. They were buoyed by Bradley and Jean's visit and assistance from the Diocese. Their buildings are in very good shape and immaculate. They need continued support and the ability to breath for a time. The Lutheran Pastor will begin celebrating Holy Eucharist twice a month in April, and All Saints in Whitefish/Columbia Falls has offered to pay for a third Sunday every month if the Pastor is willing. Bradley and Jean provided Lenten materials, and will remain on contact with the members of St. Mark's. Council's continued support of St. Mark's is requested.
- (2) Julie Sisler has resigned as Site Manager at Camp Marshall effective March 31, 2019. Her resignation has been accepted. The Standing Committee is searching for an Interim and also a permanent Site Manager.
- (3) The new search process for clergy in our Diocese has been finalized and will be implemented with the next new search. Our process is now aligned with the General Church Canons.
- (4) The Lake Missoula Clericus has finalized details for Clergy Conference to be held May 7-9, 2019 at Camp Marshall. This information will soon be posted on the Diocesan website.
- (5) The Standing Committee consented to elections of Bishops in the Dioceses of Northern California, Maine, San Diego, and Texas.
- (6) With respect to clergy participation in the election of our new Bishop, it was agreed: Retired clergy may come for Friday only at no expense providing they don't intend to take part in meals. To be eligible to vote, clergy must be

canonically resident and live in Montana at least 6 months of the year. ("Geographically resident within this Diocese," in Diocesan Canon 3.2.(b), shall mean living within the borders of the Diocese of Montana for 6 months out of the year or longer). In addition, each Deanery is asked to provide a youth delegate to Convention with seat, voice and vote. The youth must be under 16 years old.

- (7) The Standing Committee approved giving St. Paul's of the Stillwater rental possibility by a non-profit as long as the rental agreement is not tied to a purchase agreement.
- (8) The Standing Committee is introducing a resolution to regularize through diocesan canons, the requirements concerning background checks and safeguarding. This comes at the request of Jill Sallin.

Expense Reimbursement Guidelines - 2019. Council members reviewed proposed Expense Reimbursement Guidelines for lodging, meals and travel for 2019, specifically mileage reimbursement for volunteers. The National Church states the rate for mileage reimbursement for non-employees of the Episcopal Church is 58 cents per mile. However, the Internal Revenue Service standard mileage rate for 2019 is 14 cents per mile for service of charitable organizations. Barb Hagen, while she has no voice or vote on Diocesan Council, wishes to note in the minutes that she is concerns with the comment from the Episcopal Church Treasurer, Kurt Barnes, that reimbursing 58 cents per mile for volunteers is not income. His comments are not in line with the information Barb has received from the 2019 Church and Clergy Tax Guide by Richard Hammar, or from direction from The Rev. Canon Bill Geisler, CPA and consultant for the Church Pension Group. Following discussion, it was agreed that Barb Hagen will consult with the accounting firm that does the Diocesan Audit to get clarity on the reporting procedures needed if the Diocese pays more than the volunteer mileage reimbursement rate. Upon motion duly made and seconded, it was agreed to table this issue until Council's next meeting at which time additional information will have been obtained.

Province VI. At the request of the Standing Committee, Council members agreed to send only Sandy Williams, and The Rev. Jean Collins to the upcoming Province VI meeting.

116th Diocesan Convention Committees. Council reviewed a list of proposed committee members for the 116th Diocesan Convention to be held in July 26, 27 & 28, 2019 in Bozeman. After Council approves the list, the people named to the Convention Committees will be asked if they want to serve. Upon motion duly made and seconded, the Convention Committee list was approved as presented.

Deaneries - The Episcopal Diocese of Montana. Council members reviewed an updated information sheet regarding Deaneries in the Diocese of Montana. The list outlines the Vision, Organization, Officers, Officer Appointments, Meetings, and Convener's Duties of the Deaneries. No action is required of Council; this is just for informational purposes.

Resignations of The Rev. Richard Reynolds, and The Rev. Joan Yetter. Janis Hansen has offered to write a letter of thanks to both Richard and Joan for their service to Diocesan Council. Since Richard's term expires this year, therefore, no replacement will be sought to complete his unexpired term. Joan's term expires in 2020, therefore, it was suggested to ask The Rev. Carolyn Rosen, and The Rev. Wells Warren, if either is willing to fulfill Joan's unexpired term on Council.

Resolution from The Standing Committee. Upon motion duly made and seconded, the following Resolution as presented by the Standing Committee was approved.

That the membership of the Standing Committee, and the Diocesan Council, as they are currently comprised, be allowed to continue in office until December 31, 2019.

This will allow for continuity during our time of transition until the Bishop Diocesan is ordained on December 7, 2019.

General Convention Resolutions. Council members completed the following forms from the Episcopal Church – General Convention:

- Resolutions Referred to Dioceses for Action or Consideration.

Canon Clark Sherman, Jerry Southwood and Cathy Morris. Council members The Rev. Randy Pendergraft and George Kimmet were absent. Also in attendance were The Rev. Steven Yurosko, Diocesan Treasurer; Barb Hagen, Canon for Administration and Finance; Gayle Gallik Archey, Diocesan Secretary; and The Rev. Jean Collins, Liaison from the Standing Committee.

Call to Order / Adoption of Agenda. With a quorum participating in the call, Vice President, The Rev. Janis Hansen, called the meeting to order. Janis opened the meeting with prayer. The agenda as previously distributed was accepted.

OLD BUSINESS.

Minutes of March 16, 2019 Meeting. Upon motion duly made and seconded, the Minutes of the March 16, 2019 Diocesan Council meeting were approved as presented.

Update - Oil and Gas Lease Information. Janis Hansen stated next week, she will meet with Larry, a parishioner who works in the oil and gas industry, to review the Oil and Gas Lease the Diocese received from LoneTree Energy & Associates, and to gain more information on the mineral rights in Divide County owned by the Diocese. Further, Janis stated she is working to get documentation and policy in order. Barb Hagen said the Diocese also owns mineral interests by Scobey.

Vacancies on Diocesan Council. Janis Hansen announced The Rev. Wells Warren has accepted an invitation to join Diocesan Council and complete the term vacated by The Rev. Joan Yetter, which expires in 2020. Upon motion duly made and seconded, it was agreed to accept Fr. Warren as a member of Diocesan Council. Fr. Warren will be in attendance at Council's May 2019 meeting. Further, it was agreed to not fill the vacancy caused by the resignation of The Rev. Richard Reynolds, as his term expires this year.

Follow-Up: Dillon Assessment. Janis Hansen has reached out to the Treasurer of St. James Church in Dillon to discuss their monthly assessment payments for 2019, but has not yet heard back.

Outline for Council Visits to Parishes. Council members reviewed a draft Outline to be followed when making visitations to parishes. The consensus of Council was that the outline was well written, explains the assessment process for churches, and the un-balanced Diocesan budget.

Site Manager's House at Camp Marshall. Barb Hagen stated that with the change of the Site Manager at Camp Marshall, the Diocese has incurred additional expenses related to the Site Manager's house. The house needs a new stove, washer, dryer and dishwasher. Also, it is anticipated that electrical updates will be needed to the home. The current estimate for appliances, delivery, installation and electrical work is \$6,665.82. A source of funding needs to be found, as the Camp Budget does not provide for such expenses. Barb Hagen said the expenses can be paid from the Camp Investment Account, or alternatively, from the Faber Fund. Upon motion duly made and seconded, it was agreed to use the Faber Fund to pay for repairs and new appliances for the Site Manager's house. The candidates have until Friday, April 12, 2019 to inform the Standing Committee whether they will allow their name to be placed on the slate and will serve if elected. The slate will be announced to the Diocese after Easter and prior to May 1, 2019. At that time, there is a two week period for others to petition into the process. The Petition Process is the means by which a qualified person, not initially part of the slate, can be nominated for inclusion on the Slate of Candidates.
- (4) St. Mark's in Havre continues to rest, reflect and move forward. Beginning this month (April), they will have Holy Eucharist twice a month. All Saints' in Whitefish/Columbia Falls has offered to pay for a third Sunday every month. St. Mark's is excited to have an Easter Day Holy Eucharist Service with 'live music'!
- (5) Much accomplished, much still to be done.

Call to Order / Adoption of Agenda. With a quorum in attendance, Vice President, The Rev. Janis Hansen, called the meeting to order and offered the opening prayer. The meeting agenda was adopted as presented. A welcome was extended to The Rev. Wells Warren from St. James' Church in Dillon, who will serve a one year term on Council to complete the term vacated by The Rev. Joan Yetter.

Presentation by Brandon Costley, Branch Director of RBC Wealth Management. Brandon Costley reviewed RBC's role managing the Diocesan investments, and gave a performance summary of all investments contained in the Diocesan portfolio. Brandon stated the Diocesan Investment Policy Statement is reviewed quarterly with the Diocesan Foundation Board.

Funding Request for Disaster Services. Council members welcomed The Rev. Mary Alice Jones and The Rev. Jim Jones, to the meeting. Mary Alice serves as the Disaster Coordinator for the Diocese, and comes before Council to request a line item be included in the 2020 Diocesan budget for Disaster Services. Mary Alice also requested, if possible, the line item for Disaster Services be funded to pay expenses associated with travel and conducting Asset Mapping worships in parishes throughout our Diocese. Asset Mapping is a process that focuses on hope and what we do have, not what we don't have. Thanks were offered to Jim and Mary Alice for coming before Council with their request.

OLD BUSINESS

Minutes of April 9, 2019 Conference Call. Upon motion duly made and seconded, the Minutes of the April 9, 2019 Diocesan Council conference call were approved as presented.

Financial Reports. Barb Hagen and The Rev. Steven Yurosko presented the financial statements as of April 30, 2019. Upon motion made and seconded, it was unanimously agreed to accept the April 30, 2019 Diocesan financial reports. The Rev. Wells Warren stated St. James in Dillon is unable pay their 2019 monthly assessment amount. As the new Rector at St. James, Wells asked for guidance. It was suggested that he talk with the Vestry and the Treasurer of St. James, and come up with a plan to present to Council to request a reduction in their monthly assessment amount. Additionally, Incarnation in Great Falls has communicated with Barb Hagen the inability to pay their 2019 monthly assessment. Barb stated Incarnation is making arrangements to come before Council to request a reduction in their assessment amount.

Parish Audit Report Update. Barb Hagen stated Incarnation in Great Falls is 2 years past due submitting their Audit Reports to the Diocesan office. 2017 Audit Reports from all other parishes have been received. It was noted the 2018 Audit Reports are due September 1, 2019.

Update Oil and Gas Lease in Divide County, North Dakota. The Rev. Janis Hansen stated her investigation continues into the mineral interests in Divide County, North Dakota the Diocese now owns. Janis is searching for ownership records (i.e., deeds) for the mineral interests which will hopefully provide additional information.

Update on Church Visits.

- 1. St. Paul's Virginia City. Janis Hansen visited St. Paul's Church. They have a new Treasurer. Janis will provide notes from the visit when completed.
- 2. St. Paul's Fort Benton. Janis and Dorcie visited with the parishioners of St. Paul's Church on May 17, 2019. The parish is having challenges with future transitions and changes in management. The Church building is owned by the City of Fort Benton. When Janis has completed her report, she will provide it to Council members.
- 3. St. Mark's Big Timber. Janis Hansen, Manny Hoag, and Warren Wells plan to visit St. Mark's in the near future.

How can Council help and assist to enable Churches to stay open? It was noted that 19 churches have closed in the Diocese of Montana over the last 18 years. Other items noted for future discussions were installation of fire alarms and other safety equipment in all Churches, and safety issues for Sanctuary Churches.

NEW BUSINESS

Report of the Standing Committee. The Rev. Jean Collins, Liaison from the Standing Committee to Diocesan Council, gave an update on the work of the Standing Committee. The Standing Committee continues to meet weekly via Google Hangout, and once a month in person in Helena.

- 1. Anna and Tony Hudson, parents of Wyatt Hudson (age 19), who died in a car accident on Dec. 27. 2018, are donating a school bus to Camp Marshall in memory of Wyatt. The bus is automatic, air conditioned and seats 24 with a lift mechanism for wheelchairs. The bus will be delivered to Camp Marshall by the first week of June. Camp Marshall was important to Wyatt. Sue LaRose recently met with Wyatt's family in Stevensville.
- 2. The slate of candidates for Diocesan Bishop was announced to the Diocese on May 1, 2019. No individuals petitioned into the 2-week Petition Process. The Standing Committee is very grateful to the Nominating Committee for their work, and three outstanding candidates.
- 3. The Standing Committee continues to work with the Transition Committee to work out details of the Walkabouts, and the ordination of our next Bishop.
- 4. A very successful and fun Clergy Conference was held at Camp Marshall on May 7-9, 2019. The Conference was planned and implemented by the Lake Missoula Clericus, and supported by the Standing Committee. Items to come from the conference included a Montana Clergy Closed Facebook page, intentional community building by pairing interested ordained folk in the Diocese for the next year in order to become better acquainted with one another, and the beginnings of a clergy directory which includes what gifts we have that we are able and willing to share in the Diocese. Thanks were offered to Council for their financial support for this endeavor. It was the best clergy attendance, with the possible exception of when Presiding Bishop, Michael Curry, was present with us.
- 5. A priest from Calgary, Alberta, Canada, The Rev. Bryan Beveridge, is moving to Big Timber after a year-long process to complete his immigration. All

- congregations in the Diocese now have clergy, with the exception of The Rev. Carolyn Rosen, who announced her resignation as Rector of St. Stephen's in Billings effective August 1, 2019. Carolyn's husband, Aaron, has accepted a position at Wesley Theological Seminary, and will be moving to Washington, D.C. for this position, and to be closer to aging and infirmed family members.
- 6. Mark Clemow began work as the new Camp Marshall Site Manager on April 1, 2019. The Standing Committee thanks the Council for financial support in repairing the electrical outlets in the Site Manager's home, and the purchase of new appliances.

2020 Diocesan Budget. Barb Hagen and The Rev. Steven Yurosko, presented the proposed 2020 Diocesan Budget prepared by the Finance Department, which is comprised of three separate budgets: Administration, Program and Camp Marshall. The 2020 Budget is based on a 19% assessment, calculated on an average of each Parish's Parochial Reports for the prior 3 years. 2020 will be the second year the Diocese has used this assessment calculation. Barb Hagen stated there were reserve funds from the 2019 Budget to be used for the 2020 Budget, and the 2020 Budget utilizes \$29,029.00 from the 2019 budget reserve funds. The camp assistance line item of the Camp Marshall budget has been increased from \$12,000.00 per year to \$27,000.00. The additional amount represents the \$15,000.00 savings in health insurance from family coverage to single for the new camp site manager, which will be transferred to help fund the camp assistance budget.

Following review and discussion, Council amended the line item for salaries, and also added a new line item for Disaster Services for \$1,000.00. Upon motion duly made and seconded, the 2020 balanced Budget was approved as amended. The Budget will next be presented to the Diocesan Convention delegation in July for acceptance.

Grant Report from St. James in Lewistown. Council members acknowledged receipt of the 2nd Statement of Grant Accounting from St. James in Lewistown. The report is an accounting of the \$3,906.89 balance remaining from the Vicker's Fund grant St. James received from the Diocese for their Youth Choir.

Convention Attendance. A discussion was held on whether members of Diocesan Council and the Standing Committee will be able to vote at Convention. Additionally, it was noted that each of the four Deaneries will send one youth delegate (under 16 years of age), to Convention.

Books and Vestments. Barb Hagen invited everyone to the Diocesan office to look through a collection of books and vestments, all of which are free for the taking.

> Episcopal Diocese of Montana Minutes of Diocesan Council Conference Call June 18, 2019

The Diocesan Council of the Episcopal Diocese of Montana held a meeting via conference call, beginning at 6:30 p.m. on Tuesday, June 18, 2019.

Attendance. Council members present were: Sandy Williams, Cynthia Hoelscher, The Rev. Janis Hansen, The Rev. Dorcie Dvarishkis, Jerry Southwood, The Rev. Wells Warren, Manny Hoag and The Rev. Randy Pendergraft. Council members Cathy Morris, The Rev. Canon Clark Sherman and George Kimmet were absent. Also in attendance were The Rev. Steven Yurosko, Diocesan Treasurer; Barb Hagen, Canon for Administration and Finance; Gayle Gallik Archey, Diocesan Secretary; and The Rev. Jean Collins, Liaison from the Standing Committee.

Call to Order / Adoption of Agenda. With a quorum participating in the call, Vice President, The Rev. Janis Hansen, called the meeting to order. Janis opened the meeting with prayer. The agenda as previously distributed was accepted.

Discussion with Members of Incarnation-Great Falls. On behalf of The Church of the Incarnation in Great Falls, The Rev. Tim Ljunggren, Rector; Gretchen Swift, Treasurer; and Sara Quay, Sr. Warden joined the conference call to request their 2019 monthly assessment payment be reduced to \$500.00 per month. Although they

have made the Jan., Feb. & March 2019 assessment payments of \$2,275.93, this monthly amount is more than the parish can afford. Incarnation has struggled to pay their assessment since 2011. Gretchen Swift, Treasurer, provided Council members with the parish's financial statements for the first 5 months of 2019. After Fr. Tim, Gretchen and Sara disconnected from the call, it was decided that Janis Hansen and Clark Sherman will make arrangements to visit Incarnation, then report back to Council.

OLD BUSINESS.

Minutes of May 18, 2019 Meeting. Upon motion duly made and seconded, the Minutes of the May 18, 2019 Diocesan Council meeting were approved as presented.

Parish Audit Report Update. Barb Hagen stated Incarnation-Great Falls is 2 years past due submitting their Audit Reports. When Janis Hansen and Clark Sherman visit Incarnation in the near future, they will also discuss the past due Audit Reports. 2017 Audit Reports from all other parishes have been received. 2018 Audit Reports are due September 1, 2019.

Report of the Standing Committee. The Rev. Jean Collins, Liaison from the Standing Committee to Diocesan Council, gave an update on the work of the Standing Committee.

The Standing Committee continues to work with the Transition Committee regarding the details of the Walkabouts and the ordination of our next Bishop. The 5 written questions have been completed and will be sent to the candidates by the Transition Committee. Those written responses will be published on our Diocesan website and printed copies will be available at each of the 6 Walkabout sites. The schedule for the Walkabouts has been finalized. The Special Rules of Order for the electing convention have been completed.

Appointments to various committees and commissions is hopefully complete. Standing Committee President, Donna Gleaves, will contact potential appointees confirming their willingness to serve - or not.

Grace Camp is underway.

The Standing Committee continues to meet weekly via Google Hangout, or Go To Meeting, and once a month in person in Helena. They just met in person this morning (June 18).

Update-Oil and Gas Lease Information. Janis Hansen stated there is nothing new to report regarding the oil and gas leases, but her quest continues.

Safety Issues / Church as Sanctuary. Barb Hagen is waiting for a response or recommendation from the Diocesan Chancellors with regard to safety issues and Church as sanctuary. The Rev. Wells Warren made inquiries to the university and hospital in Dillon regarding fire safety issues. He found that both of their systems are not adequate. Wells feels this is a serious problem for our Churches and needs to be addressed. The safety issue for churches will remain on Council's meeting agenda for future discussion.

It was decided the Diocesan office will conduct a poll of all Churches in the Diocese to determine how they handle fire safety issues. Questions for the safety poll are:

- 1. Is your church equipped with a fire alarm system?
- 2. How do you notify the police of an emergency? Do you have an alarm system?
- 3. Do you have smoke detectors or carbon monoxide detectors?
- 4. Do you have a local volunteer fire department or municipal services?
- 5. What is their capability?
- 6. Do you have a policy on emergency action response (also known as an emergency action plan)?
- 7. Any other questions or comments you wish to add regarding safety in your church?

Update on Church Visits.

1. <u>St. Paul's, Virginia City.</u> Janis Hansen visited St. Paul's on May 2, 2019, and met with The Rev. Jaime Leonard, Amy Grice, Janet Doornboss and David Hansen. Janis reports the parishioners find joy in "the family" of their Church and Diocesan life. Their challenges are that they are small, but have good attendance, the liturgy, and how to provide music and incorporate Native prayers in worship. During the visit, Janis discussed the assessment in terms of the Parochial Report - specifically line 4, which included funds already assessed, resulting in a skewed 3 year rolling average amount. This was easy to adjust and the Treasurer now knows what income to report on line 4.

- 2. <u>St. Paul's, Fort Benton</u>. Janis Hansen and Dorcie Dvarishkis visited St. Paul's on May 17, 2019. Their report has been sent to the parishioners of St. Paul's for their review. Once reviewed by St. Paul's, the report will be presented to Council.
- 3. <u>St. Mark's, Big Timber</u>. Janis Hansen, Manny Hoag and Wells Warren have not yet had an opportunity to visit with the parishioners of St. Mark's, but plan to make arrangements to do so in the near future.

NEW BUSINESS.

Parking Lot Tax. Barb Hagen explained the IRS has come out with a ruling regarding designated staff parking spaces. The Diocese has 25 parking spaces; of those, 5 spaces are designated as employee parking for Diocesan staff, and 3 spaces are designated for St. Peter's Cathedral staff. The Diocese has a total of 8 spaces reserved for employees. Since the Diocese is below 50% of designated spaces for employees, there should be no issue. Barb said they have removed the signage for the designated employee parking spaces in order to mitigate any future issues. If the Diocese is using more than 50% of the parking spaces for employee use, the IRS will impose a 21% tax on any expenses allocated to employee use greater than \$1,000.00. Since the Diocese shares the parking lot with St. Peter's Cathedral, and St. Peters pays most of the expenses, a formal agreement should be worked out between St. Peters and the Diocese.

Statements of Grant Accountings. Council members acknowledged receipt of Grant Accounting Reports, as follows:

- 1. <u>St. Andrew's Philipsburg</u> spent \$13,588.00 renovations to their Church building, consisting of a new roof, front doors, side door for wheelchair ramp, and a deck with a concrete ramp and sidewalk.
- 2. Of the \$8,750.00 Vicker's Grant the <u>Lake Missoula Clericus</u> received, they have used \$845.00 for expenses associated with their annual conference held May 7-9, 2019. Although the conference was originally proposed as a standalone event, this year it was held in conjunction with Clergy Conference. As a result, expenses associated the conference were minimal. The unused funds were returned to the Diocese.
- 3. Although no report was received from <u>St. Stephen's Billings</u>, it was noted they have not spent the \$50,000.00 Vicker's Grant money they received last year. Steven Yurosko will reach out to St. Stephens to get an update as to when they plan to use the money.

Fence Repair. Council members reviewed a \$1,000.00 proposal from Fencecrafters, for repair work to the existing 6' chain link fence around the Diocesan office property. It is hopeful this work can be completed prior to the bishop candidate visits. Upon motion duly made and seconded, it was agreed to accept the proposal for the fence repair.

Insurance Recommendations. Barb Hagen presented the Minimum Insurance Recommendations for the Diocese for Council's review. The list was updated June 2019, and includes minimum insurance requirement limits for Commercial, Directors & Officers, Workers' Compensation and Umbrella policies to be used as a guideline for churches that obtain insurance coverage from another insurance company other than the National Church.

Episcopal Diocese of Montana Minutes of Diocesan Council Meeting September 14, 2019

The Diocesan Council of the Episcopal Diocese of Montana held a meeting at the Diocesan Office in Helena, beginning at 10:00 a.m. on Saturday, September 14, 2019.

Attendance. Council members present were: Sandy Williams, Cynthia Hoelscher, The Rev. Janis Hansen, Cathy Morris, Manny Hoag and George Kimmet. The Rev. Dorcie Dvarishkis participated via phone. Also in attendance were newly elected Council members whose terms will commence January 2020 included The Rev. Stephen Day, Hope Stockwell and Keith Kuhn. Council members Jerry Southwood, The

Rev. Wells Warren, The Rev. Randy Pendergraft and The Rev. Canon Clark Sherman were absent. Also in attendance were The Rev. Steven Yurosko, Diocesan Treasurer; Barb Hagen, Canon for Administration and Finance; Gayle Gallik Archey, Diocesan Secretary; and The Rev. Jean Collins, Liaison from the Standing Committee.

Call to Order / Adoption of Agenda. With a quorum present, Vice President, The Rev. Janis Hansen, called the meeting to order, then members introduced themselves. Janis offered the opening prayer. The agenda as previously distributed was accepted.

Steve Hagen, Helena Interim Chief of Police, spoke to Council about Church Security. Steve urged each Church to have a safety committee, who works with their local law enforcement. Steve stressed the importance of building a relationship with local law enforcement. The average response time for police in many emergencies is 3 minutes, whereas, for medical help, it is 17 minutes. One should be aware of the entrances, exits, and the physical layout of the area. Steve stated it is best to call 911 as opposed to using a "panic button" to alert a security company. Steve mentioned different types of training available, including active shooter training, Run-Lock-Fight, de-escalation training, and Stop the Bleed. The key is to slow the person down during an active shooter, and just do something.

OLD BUSINESS.

Minutes of June 18, 2019 Conference Call. Upon motion duly made and seconded, the Minutes of the June 18, 2019 Diocesan Council conference call were approved as presented.

Financial Reports. Barb Hagen and The Rev. Steven Yurosko presented the financial statements as of July 31, 2019. Several assessment payments have come in, and investments are doing well. Upon motion duly made and seconded, it was unanimously agreed to accept the July 31, 2019 Diocesan financial reports.

Parish Audit Report Update. Barb Hagen stated the 2018 audit report from Church in Absarokee has not been received. The church is now closed. The Diocesan office has received the 2017 and 2018 Audit Reports from Incarnation in Great Falls. 2017 Audit Reports from all other parishes have been received. 2018 Audit Reports have not yet been received from Ascension in Forsyth, St. John's in Butte, and St. Andrew's in Polson.

Report of the Standing Committee. The Rev. Jean Collins, Liaison from the Standing Committee to Diocesan Council, gave an update on the work of the Standing Committee.

The Standing Committee continues to work with the Transition Committee regarding the ordination of Bishop-Elect, Marty Stebbins. The Standing Committee met with the Bishop-Elect on September 6, 2019 in Helena to get acquainted and bring her up to speed on some happenings in the Diocese. Marty and her husband have found a Helena house to purchase. Her Letter of Agreement is in process.

Episcopal Relief and Development is sponsoring an orientation to 1,000 Days of Love in Los Angeles later this month. As Barb Hagen and several parish ERD representatives are unable to attend, Jean Collins will be representing the Diocese of Montana. The 1,000 Days refers to the first 1,000 days of a child's life.

Camp Marshall. A Debrief meeting with camp and diocesan staff was held on September 11, 2019 in Helena. The Capital Campaign is nearing the end of its 3-year time period on December 31, 2019. The bus which is being donated to the Diocese has hit a title snag, but is nearing completion.

The Rev. Mary Jacques passed away September 5, 2019. Please keep Mary's family and friends in your prayers. Also keep The Rev. Angel Bolling in your prayers.

Churches in the search process for a new Rector include: St. Stephens in Billings, and All Saints in Columbia Falls/Whitefish.

In concert with Bishop-Elect Marty, we are requesting from The Rt. Rev. Neil Alexander, Dean of our seminary in Sewanee, TN, a discernment committee for Andrew Sloan, from Incarnation in Great Falls, who has completed his first year of seminary at Sewanee.

The Standing Committee continues to meet weekly via Go To Meeting, and once a month in person in Helena.

Update - Oil and Gas Lease Information. The Rev. Janis Hansen stated she has tracked down the Mineral Deed evidencing ownership of the mineral interests the Divide County North Dakota. Janis has requested a copy of the Mineral Deed from the Divide County Recorder's office, and when received, it will be distributed to all Council members. Further, Janis will deliver all her notes and correspondence regarding the mineral interest search to the Diocesan office, so all records can be in one location.

Expense Reimbursement Guidelines. Council members reviewed a Resolution from the Standing Committee to amend the Diocesan Expense Reimbursement Guidelines. The amendment would expand the volunteer travel reimbursement to include the current IRS Mileage Rate, which for 2019 is 58 cents per mile. Those volunteers seeking reimbursement would still have the option to receive 14 cents per mile, or to be paid for actual expenses by submitting expense receipts. Mileage reimbursement of \$600 or more in a calendar year is considered taxable income, and the volunteer receiving such taxable income will be issued an IRS Form

1099-MISC.

Upon motion duly made and seconded, it was agreed to revise Paragraph 2 and Paragraph 5 of the Travel Reimbursement section of the Expense Reimbursement Guidelines-2019, to be effective September 15, 2019, as follows:

TRAVEL REIMBURSEMENT

- 2. When driving, mileage is paid for elected or appointed Diocesan volunteers at 14 cents per mile, the current federal government mileage rate, or actual costs with original receipts. Where appropriate, 1099s will be provided by the Diocese.
- 5. If the volunteer, staff member, or deputy chooses to drive, they may be reimbursed at 14 cents per mile, the current federal government mileage rate, or actual gas expenses for the most direct route up to the amount of what the airfare would have cost. Motels and meals will be covered for car travel, only to the extent of the difference between the costs of car travel vs. airfare. Original receipts must accompany reimbursement.

Safety Issues / Church as Sanctuary. Council members reviewed a Report from Vice Chancellor, Julianne Burkhardt, regarding a Sanctuary Church Endorsement offered by the Church Insurance Company. It was suggested to share this Report with all parishes. Also reviewed was the Church Safety Poll that Barb Hagen compiled from information obtained from a survey wherein 10 churches from around the Diocese participated. It was recommended that churches have an evacuation plan, with individuals who sweep the building on the way out to make sure everyone is out of the building. It was suggested to check with The Rev. Mary Alice Jones, the Disaster Preparedness Coordinator for the Diocese, to see if she has a plan for evacuations.

Update on Church Visits.

- 1. <u>St. James, Dillon</u>. Janis Hansen and Manny Hoag plan to visit St. James in Dillon to discuss their 2019 assessment payments, then report back to Council.
- 2. <u>St. Paul's, Fort Benton</u>. Janis Hansen, David Hansen and Dorcie Dvarishkis visited St. Paul's on May 17, 2019, meeting with Gail Good, Sue Lepley, Margie Hansen and Shirley Lenington. They love their Church and want more members. The fellowship between members gives them joy. Support they would like includes more people, Lay Eucharistic Ministers, more social gatherings, a greater sense of stability, and an increased presence of a priest.

- 3. <u>St. Mark's, Big Timber</u>. Janis Hansen and Manny Hoag visited with Jami Horton, Sarah Gregie, Jaime, Jill Brown, and The Rev. Brian Beveridge from St. Mark's on July 18, 2019. They expressed the joys and challenges of their parish. Areas of concern include: need for better communication, financial issues, i.e., assessment payments, pension costs and insurance premiums.
- 4. <u>Incarnation, Great Falls</u>. Upon motion duly made and seconded, it was agreed to reduce Incarnation's monthly assessment payment by one-half, to \$1,137.97 for the 8 months in 2019 they have not yet paid. Janis Hansen and Keith Kuhn will plan a follow-up visit with members of Incarnation in Great Falls.

NEW BUSINESS.

Faber Fund Grant Application – Forsyth. Council members reviewed an Application for Faber Fund Grant from Church of the Ascension in Forsyth for \$2,240.00 to be used to replace the exterior siding on the North side of the Church building. The Finance Department recommends approval of this Application. Upon motion duly made and seconded, it was unanimously agreed to approve the Grant Application.

Faber Fund Grant/Loan Application – St. Peter's Cathedral. Council members next reviewed a Faber Fund Grant/Loan Application from St. Peter's Cathedral in Helena for \$55,000.00 to be used to replace the condemned boiler in the Church building. The Application requests a \$10,000.00 grant, and a loan for the balance of \$45,000.00 to be repaid over a 5 year period at no interest. Upon motion duly made and seconded, the Application was approved. Council member, Cathy Morris abstained from voting as she is a member of St. Peter's Cathedral.

Budget Revisions. The additional expenses incurred as a result of the Bishop's Search and Transition Expenses has resulted in an impact of an additional \$14,858.00 on the 2019 Diocesan Budget. Additionally, uncollected assessment payments have resulted in \$41,000.00 less income for the 2019 Budget. Barb Hagen stated the 2019 Budget contains a \$162,137.00 reserve fund, which can be used to cover these deficits.

Minutes of 116th Convention of the Episcopal Diocese of Montana. Upon motion duly made and seconded, it was unanimously agreed to approve the Minutes of the 116th Diocesan Convention held July 26, 27 & 28, 2019 in Bozeman, Montana.

Diocesan Audit Report. Upon motion duly made and seconded, Council members acknowledged receipt of the Diocesan Audit Report.

Stipend for Standing Committee. A suggestion was made to do something to thank the six members of the Standing Committee for all the time and effort they have expended this past year serving as the Ecclesiastical Authority of the Diocese, and with the Bishop Search. It was decided to continue this discussion at the November meeting.

2020 Roanridge Trust Grants. Dorcie Dvarishkis stated Roanridge Trust Grants are available to our Diocese for leadership development in small towns and rural communities. The grants are awarded annually. The application deadline is December 14, 2019. Barb Hagen will send more information regarding the Roanridge Trust Grants to all parishes. Such a grant might be considered to pay for the training Mary Alice Jones does for her Asset Mapping Ministry.

Future Diocesan Council Meeting. Council's next meeting will be held via conference call on Saturday, November 2, 2019 at 10:00 a.m.

Council members Sandy Williams, Cynthia Hoelscher, Manny Hoag and Keith Kuhn were absent. Also in attendance were The Rev. Steven Yurosko, Diocesan Treasurer; Barb Hagen, Canon for Administration and Finance; Gayle Gallik Archey, Diocesan Secretary; The Rev. Jean Collins, Liaison from the Standing Committee; and The Rev. Martha ("Marty") E. Stebbins, Bishop-Elect of the Diocese of Montana.

Call to Order / Adoption of Agenda. With a quorum participating in the call, Vice President, The Rev. Janis Hansen, called the meeting to order and offered the opening prayer. The agenda as previously distributed was accepted.

OLD BUSINESS.

Minutes of September 14, 2019 Meeting. Upon motion duly made and seconded, the Minutes of the September 14, 2019 Diocesan Council meeting were approved as presented.

Financial Reports. Council members reviewed the Diocesan financial statements as of September 30, 2019. Barb Hagen stated it was a good month for investments. Assessment payments are being received. Upon motion duly made and seconded, it was unanimously agreed to accept the September 30, 2019 Diocesan financial reports.

Parish Audit Report Update. Barb Hagen stated 2018 audit reports have been received from all parishes, with the exception of the Church in Absarokee, which is now closed. The members of the Absarokee Church are working to complete the report.

Audits from Foundations and Endowments within the Diocese. A suggestion to request annual audit reports from church foundations, endowments and the Bishop Fox Company was tabled for future discussion.

Report of the Standing Committee. The Rev. Jean Collins, Liaison from the Standing Committee to Diocesan Council, gave an update on the work of the Standing Committee.

A Camp Marshall Committee has been formed. Mary Messina serves as Chair. Current members include Cynthia Benkelman, Mark Clemow, Bryan Beveridge, Steven Day, Rick Harden, Janelle Fuller Willet, Bishop-Elect Marty Stebbins, and Diocesan Staff: Barb Hagen and Jill Sallin.

A job description has been developed for a full-time Executive Director of Camp Marshall. An advertisement has been posted on the Diocesan website, the official Episcopal Camps and Conference Centers (ECCC) website, and with the ACA (American Camp Association) website. Application deadline is December 1, 2019. Sue La Rose was signed to a 2-year contract by Bishop Brookhart, which expires December 31, 2019. The Camp Marshall Committee will screen candidates and submit an acceptable list to Bishop-Elect Marty.

A discussion about Day Camps has commenced, and a questionnaire is being developed to send to all congregations for input regarding Day Camps.

Camp fees for the 2020 camping sessions will reflect a modest increase.

The Standing Committee continues to support the Transition Committee in its work.

Churches in the search process for a new Rector include: St. Stephens in Billings, and All Saints in Columbia Falls/Whitefish.

Prayers are requested for The Rev. Angelique Bolling. Angel has been diagnosed with an aggressive brain cancer. She is receiving 6 weeks of treatment in Kalispell. Her living situation in Kalispell is ideal, and she is receiving great support from the Lake Missoula clergy and her congregation, Holy Trinity in Troy. The Standing Committee and Diocesan staff have been in conversation with the Pension Plan regarding resources available for Angel. She is approved for short term disability at this time. The Standing Committee is also in communication with the Episcopal Diocese of Spokane and the ELCA Synod in Montana seeking ongoing clergy coverage for the congregation. This includes the possibility of yoking with Sandpoint or Bonners Ferry, and perhaps supply clergy from retired ELCA clergy in the Libby/Troy area.

All clergy in the Diocese of Montana have been requested to submit their resignations by December 9, 2019, if they have reached the age of 72. This is a canonical requirement. Those clergy may be appointed for an additional year (and years beyond that) to their current or perhaps different ministry. The Bishop makes these yearly appointments.

All clergy in the Diocese are currently up to date on their Safeguarding God's Children, and Safeguarding God's People certifications. This has been a frustration for the Diocesan staff who oftentimes find clergy unresponsive to this and other issues.

A Letter of Agreement with Bishop-Elect Marty will be signed in the near future.

A new policy on sabbaticals for Clergy in the Diocese has been written, proposed, and is currently in the hands of Bishop-Elect Marty.

The Standing Committee continues to meet weekly via Go To Meeting, and once a month in person in Helena. The Standing Committee has met twice with Bishop-Elect Marty, and will meet again with her on November 12, 2019. New Standing Committee members, The Rev. Terri Grotzinger and Laura Catlin, will attend the Nov. 12th meeting.

Church Visit Updates.

<u>Incarnation, Great Falls</u>. At their September meeting, Council voted to reduce Incarnation's monthly assessment payment by one-half for the last 8 months of 2019. A follow-up visit to Incarnation has been postponed.

St. James, Dillon. Janis Hansen, Manny Hoag and Wells Warren recently met with members of St. James. A review of the 2019 financial records and their projected 2020 budget was recommended. The Rev. Wells Warren, Rector at St. James, did a

stewardship campaign over a 4 week period. A follow-up visit to St. James was suggested to help them work on areas that need improvement.

Stipend/Honorarium for Standing Committee & Diocesan Staff. Upon motion duly made and seconded, it was agreed to give an honorarium gift of \$1,000.00 to each of the 6 members of Standing Committee for their work during 2019 serving as the Ecclesiastical Authority of the Diocese and the Bishop Search. Further, it was agreed to give Barb Hagen and Jill Sallin \$1,166.50 each (includes FICA tax and pension), for the extra time and effort they expended managing the Diocesan office during 2019.

Safety/Emergency Response Plans. Council members reviewed results of a Diocesan safety poll conducted by Barb Hagen, and a couple of responses received by other diocesan administrators regarding emergency planning. It was suggested a subcommittee be formed to develop a safety plan that will address fire safety in Churches, work with local police and first responders with respect to acts of violence in Churches, and domestic terrorism. Those serving on the sub-committee should have expertise in safety and disaster preparedness. The Rev. Mary Alice Jones, the Disaster Services Coordinator for the Diocese, would be an excellent member of the sub-committee. Hope Stockwell volunteered to serve as Chairperson of the sub-committee. The subcommittee will report back to Council in January 2020.

Update - 2020 Roanridge Trust Grants. The Rev. Dorcie Dvarishkis will check with The Rev. Donna Gleaves to confirm the deadline to submit applications for 2020 Roanridge Trust Grants. Roanridge Trust Grants are available for leadership development in small towns and rural communities.

NEW BUSINESS.

2020 Assessment Requests. Council members discussed a letter received from St. Mark's Church in Big Timber. Due to a number of challenging issues, they are requesting an adjustment of their 2020 monthly assessment payments to the Diocese. Additionally, St. Mark's requests to be designated a "Mission Parish" for a 5-year period, to obtain Diocesan assistance. St. Mark's will be informed that Council is working on this matter and will respond to St. Mark's request when a plan has been developed. It was noted that St. Mark's request might be combined with similar requests which will surely be received from other Churches for 2020. Barb Hagen suggested the possibility of having an Application for parishes to complete when requesting assistance with their 2020 assessment payments. Bishop-Elect Marty agreed with this suggestion.

Revision to 2019 Diocesan Budget. Upon motion duly made and seconded, Council approved the addition of \$3,000 to the 2019 Diocesan Budget to cover expenses associated with the search process for a new Camp Director.

2020 Diocesan Budget Changes.

- 1. The payment to the General Church is \$1,434.00 less than budgeted.
- 2. \$300.00 more is needed for health savings funding.
- 3. An additional \$12,637.00 is needed for the Camp Director, as it was originally budgeted for a 3/4 time position, and will now be a full-time position.
- 4. An additional line item expense of \$1,000.00 to cover the costs of the newly formed Camp Marshall Committee.

Barb Hagen stated there is some flexibility in the 2020 Budget to cover the above-referenced additional expenses. Upon motion duly made and seconded, the proposed changes to the 2020 Diocesan Budget were approved.

It was noted that the Standing Committee acted out of order with respect to the search for a new Camp Director. The Application process for a full-time Camp Director was started without funding approval from the Diocesan Council.

Adjustments to 2020 Camp Marshall Budget. Now that the 2019 camp season is over and final income and expense figures are known, it is anticipated that the proposed 2020 Camp Marshall Budget will have a \$35,087.00 shortfall. The Standing Committee has asked the Finance Department and Diocesan Council to consider raising the 2020 Diocesan Assessment to 20% to cover the Camp budget shortfall. Several Council members voiced their disapproval to increasing the assessment percentage. Upon motion duly made and seconded, it was agreed to table this issue until Council's January meeting to allow time to obtain additional information and to do more research.

Acceptance of Finance Department Minutes. Upon motion duly made and seconded, Council members acknowledged receipt of the Department of Finance meeting Minutes of October 22, 2019.

Housing Resolutions. Upon motion duly made and seconded, the following housing resolutions were unanimously approved.

The Diocesan Council on November 2, 2019, after discussing the amount to be paid to The Rt. Rev. Martha E. Stebbins, as a parsonage allowance, on motion duly made and seconded, adopted the following resolution:

Whereas, The Rt. Rev. Martha E. Stebbins is employed as a minister of The Episcopal Diocese of Montana, which does not provide a residence for her, the Council resolves that of the total compensation of \$128,800.00 to be paid to The Rt. Rev. Martha E. Stebbins in 2020, that \$36,800.00 be designated as a parsonage allowance within the meaning of that term as used in Section 107 of the Internal Revenue Code of 1986.

The Diocesan Council on November 2, 2019, after discussing the amount to be paid to The Rev. Canon James Christopher Roberts, as a parsonage allowance, on motion duly made and seconded, adopted the following resolution:

Whereas, The Rev. Canon James Christopher Roberts is employed as a minister of The Episcopal Diocese of Montana, which does not provide a residence for him, the Council resolves that of the total compensation of \$37,499.52 to be paid to The Rev. Canon James Christopher Roberts in 2020, that \$10,000.00 be designated as a parsonage allowance within the meaning of that term as used in Section 107 of the Internal Revenue Code of 1986.

Diocesan Website. A conversation was started several months ago to consider an update of the Diocesan website. Barb Hagen has done some research and received information. Barb suggests talking with Holy Spirit in Missoula, and St. Peter's Cathedral in Helena, as both have recently updated their parish websites. Bishop-Elect Marty suggested this issue be tabled until Council's January meeting.

Diocesan Audit Review Policy. The Diocesan Audit Review Policy was last updated in 2014. It was suggested that the Finance Department review the current policy and note possible revisions, before it is brought before Council. One possible revision might be to include a provision that requires "outside" people to do the Audit Review, as parishioners may not be qualified or objective.

Election of Vice President. The Rev. Dorcie Dvarishkis was nominated to serve as Vice President of Diocesan Council for the coming year. Upon motion duly made and seconded, the nominations were closed, and The Rev. Dorcie Dvarishkis was unanimously elected to serve as Vice President of Council until the 2020 Diocesan Convention, pending approval of The Rev. Terri Grotzinger, Rector of Holy Spirit, Missoula, where Dorcie serves as Deacon.

New Diocesan Council Video. Barb Hagen asked for feedback on the *New Council Member Video* on the Diocesan website, which explains what is involved with serving on the Diocesan Council.

Bishop Fox Company. Council members reviewed an informational statement drafted by George Kimmet which gives a brief history of the Bishop Fox Company, its members and its mission.

Future Diocesan Council Meetings. 2020 meetings of the Diocesan Council are scheduled as follows:

Whereas, Council member, The Rev. Richard Reynolds, served faithfully during his time on Council.

Be It Resolved, that the Diocesan Council give thanks to Richard for his work.

Adjournment. There being no further business to come before the Diocesan Council, on motion duly made and seconded, the conference call was adjourned at 12:05 p.m. by Vice President, The Rev. Janis Hansen. Bishop-Elect Marty E. Stebbins offered the closing prayer.

COMMITTEE REPORTS



Pastor John Lund: John.lund@umontana.edu, 396-4974, www.ecmum.org Annual Report for January, 2020

Student residents and staff: We currently have 11 students living in the Ark and Emmaus House and about 20 who are active in some way with us. We have 4 student staff working on different aspects of our ministry and about 50 faculty and staff contacts.

Student Programs: This fall we have our regular **dinner and discussion** group on Wednesday nights, coordinating with the Wesley House students as well. We have had students helping with Family Promise support for First Presbyterian, Habitat for Humanity, food drives, and other projects. This past year we had a successful winter retreat at Georgetown Lake and a fall retreat on the Blackfoot River. We also had a great spring break service trip to San Francisco in the spring. We will be heading to Vancouver, BC in March.

Confluence: This fall we have started a new progressive Christian group called Confluence. This group is for students and people of all ages with a focus on Belonging, Reframing, and Action. It meets every Sunday night at UCC church from 6-8pm. We received some grant funding to hire a mostly full-time post-graduate intern, Abby Lynes to help us organize and run that program. We launched in Nov. and are finally starting to get some momentum.

Faith and Climate Action: Emmaus is the fiscal holder of this group and continues to support interns to help it run. This group is currently planning a monthly workshop series in the winter and spring of 2020 and will be working with congregations trying to develop Green Teams.

SALAM: Emmaus is also the fiscal holder for this Muslim ally group and also sponsors interns who have provided leadership along with a strong steering committee. This group offers larger community educational events, Celebrate Islam Week in the spring, and smaller educational and social events as desired and needed. We have taken a break this past semester and will see where the needs are for this group as we go forward.

Anti-Racism Work: Pastor Lund is an active member of the MLK Day planning team and is also on a small coalition of community leaders doing anti-racism work in Missoula through a group called Missoula's IDEA for racial justice. We are also helping to coordinate anti-racism work within the Missoula Interfaith Collaborative and the larger broad-based community organizing coalition that we are forming in Missoula.

Teaching: Pastor Lund continues to teach the freshmen fall Honors course called "Finding Your Path" with about 15 students each fall. He will also teach a spring MOLLI course called Decolonizing Church.

Buildings and Grounds: We have recently made our 10thpayment out of 10 to the Glacier Presbytery for the buyout of the Ark (10 year buyout). This past year we insulated the Emmaus House exterior walls, added two exterior doors, textured and painted refinished hardwood floors in the upstairs apartment, and added a paved wheelchair ramp from the front porch out to the sidewalk. We are grateful to our many volunteers and for numerous Thrivent Action Grants that have helped us pay as we go!

Chancellor's Annual Report Brad Foster

During 2019, the Diocese of Montana enjoyed an especially active and blessed year. The year started with the bishop search process already in progress, and with our Standing Committee actively serving as our Ecclesiastical Authority. Both Julianne Burkhardt, our Diocesan Vice-Chancellor, and I worked with the Standing Committee on several issues related to Camp Marshall and other legal and canonical issues that were matters for resolution. Our Diocesan canons on the bishop search and election process worked well, and we joyfully gathered in Bozeman in July to elect our wonderful new Bishop-Elect Marty Stebbins, who was consecrated and installed in a beautiful ceremony in December, 2019. Julianne and I worked with Bishop Marty both before she was installed and consecrated and after that ceremony to make the transition a good one for our Diocese. Advice was given to the Diocesan Council, several parishes and to Diocesan staff on employment issues, canonical matters, liability issues, mineral leases and financial responsibility matters.

It has been an honor and a pleasure to serve our Diocese and our new Bishop.

Commission on Ministry The Rev. Louise Baker

The COM assists the Bishop with issues involving ordained members of the clergy, including identifying those suited for ministry and continuing education for clergy. 2019 ECUMENICAL REPORT The Rev. Valerie Webster Associate Priest, All Saints in Big Sky Ecumenical & Interreligious Officer, Diocese of MT

I. Ecumenical & Interfaith Engagement in The Episcopal Church & Across the Diocese of MT

In 2019 the Episcopal Church continued to build ecumenical and interfaith relationships: (https://www.episcopalchurch.org/ecumenical-and-inter-religious-relations). We will celebrate 20 years as full communion partners with the Evangelical Lutheran Church of America in 2020. Our current, active ecumenical dialogue partners include the United Methodist Church (with possible voting for Call to Common Mission at General Convention in 2021), the Presbyterian Church (USA), and the Roman Catholic Church.

The Rev. Valerie Webster (2012-present) is delighted to serve as the Episcopal Diocesan Ecumenical and Interreligious Officer (EDEIO) for the Bishop of the Diocese of Montana and to be the Province VI EDEIO representative to the EDEIO National Board (2016-2020). In February, she met at the Duncan Center with EDEIO provincial Representatives across the church, focusing on the Call to Common Mission with the United Methodist Church. April 1-4, 2019, in St. Louis, MO, she met with EDEIOs

across the Episcopal Church and their counterparts in the Roman Catholic, ELCA Lutheran, United Methodist, at the National Workshop on Christian Unity. *From* a continuous four-day workshop on leading Taize Prayer (http://www.taize.fr/en), a contemplative, ecumenical, form of Christian worship, *to* presenting on a Panel featuring Shared Ministries, Pastor Valerie learned, taught, voted, and built relationships – all to empower ecumenical mission. She shares important ecumenical and interfaith news with the Diocese of MT – thank you Jill Sallin, who publishes "*This Week*" e-news for the Diocese of Montana [https://diomontana.com/]!

Following the lead of the Episcopal Church, many Episcopal deacons, priests, and lay leaders across the Diocese of MT participate in local and statewide ecumenical organizations, as well as, interfaith associations, such as MIC, the Missoula Interfaith Collaborative (www.micmt.org); GVIA, the Gallatin Valley Interfaith Association (www.gvinterfaith.org); and GFIA, Great Falls Interfaith Association (www.gfinterfaith.org). Focusing on specific areas of social justice advocacy (for example Deacon Steve DeHart on Abolition of the Death Penalty) or specific ministries (for example Archdeacon Roxanne Klingensmith on prison ministries), Episcopal clergy and laity provide local and statewide ecumenical & Interreligious leadership in advocacy and outreach, to use a boxing metaphor, 'well beyond our weight class.'

Since the Montana State Legislature met in 2019, this report will highlight ecumenical work through MAC, the Montana Association of Christians www.macmt.org. First, a bit of background: In 1972 Bishop Jackson Gilliam joined other judicatory heads in founding MAC, and for last 48 years, the Episcopal Diocese of Montana has supported this statewide, ecumenical non-profit through prayer, financial backing, and the engagement of our bishop, clergy and laity. MAC's mission: "make visible our unity in Jesus by educating and advocating for the justice and compassion, in our communities and our world."

MAC began the 2019 State Legislative Session by sending over 200 members to the Capital on Martin Luther King, Jr. Day for *MAC Day at the Legislature*. In carpools and on buses – Episcopalians, Lutherans, Presbyterians, UCC, Disciples, Methodists, and other Christians – from Billings, Bozeman, Missoula, Kalispell, Great Falls, and beyond assembled. [The Rev. Valerie Webster (Bozeman) and the Rev. Dorcie Dvarishkis (Missoula) served as bus captains.] Seeking to be "salt" (Matthew 5:13) at the legislature, MAC strives to participate in Jesus' prayer – "Thy Kingdom Come, Thy will be done" – by amplifying Jesus teachings (i.e., Matthew 25:31-46 – "Truly I tell you, just as you did it to one of the least of these who are members of my family, you did it to me" (v. 41). Concerned that all Montanans be treated as children of God, MAC took active positions on over 50 bills while monitoring nearly 80 total bills as MAC advocated for humane incarceration and immigration policy, care for children and families, and abolition of the death penalty.

MAC's 2019 lobbyist reported,

MAC's primary work this session was an initial effort to set standards of treatment for pregnant inmates, HB 375. While we were not ultimately successful this session in passing HB 375, we made great head-way with the Department of Corrections and the Montana Association of Counties and are well-poised to bring some truly life-changing legislation in 2021 by building an unlikely coalition to speak up for some of the most forgotten members of society—pregnant incarcerated women and their babies. MAC was able to work with our allies to pass HB 763 limiting the use of solitary confinement for juveniles, pregnant women, and the mentally ill. As the faith community knows, significant change often comes incrementally. Small steps add up to major policy improvements.

MAC was once again a valued and sought-after partner on other major policy initiatives such as abolition of the death penalty, defeating anti-immigrant legislation, advocating for child hunger solutions, starting on the path to addressing the crisis of murdered and missing indigenous women, and child abuse and youth suicide prevention. MAC clergy spoke up through letters and live testimony, because sometimes there is simply no substitute for having the message come from a member of the cloth. MAC congregants spoke up to their legislators in person, via email, and via calls all to give voice to the voiceless.

II. Additional Local and Statewide engagement of EDEIO Rev. Valerie Webster

Locally, the Rev. Valerie Webster, serves as an Associate Priest at All Saints in Big Sky, a shared ministry of the Episcopal and ELCA Lutheran Churches (2011 – Present). She continues to represent All Saints and MAC at the Gallatin Valley Interfaith Association, and she facilitates Gallatin Valley Taize Prayer, Gallatin Valley Centering Prayer, and WEBS, a Women's Ecumenical Bible Study, that's expanded to include book and video studies too.

- *Taize* (http://www.taize.fr/en)met monthly January-February at St. James Episcopal—Bozeman, and September December, at Christus Collegium (MSU). Hosts included local Episcopal, ELCA Lutheran, United Methodist, and Roman Catholic Churches.
- Centering prayer (https://www.contemplativeoutreach.org/) began in September and met monthly at Christus Collegium (MSU) with teachings from Fr. Thomas Keating's books and videos. Participants include denominational & non-denominational Christians, as well as seekers and members of AA and Al anon.
- **WEBS** met weekly with liturgical (*Lent/Easter*, *Advent/Christmas*) & summer breaks:
 - o Winter book study- Parker Palmer's **Healing the Heart of Democracy.**

- Spring video series- Center for Action and Contemplation 'Foundation Set' "Gospel Call for Compassionate Action" and "Contemplative Prayer" -- with
 Fr. Richard Rohr.
- Fall Bible Study- "The Gospel of Matthew: An Invitation to Deepen our Spiritual Journeys." Did you know that nearly all the Food Banks across Montana had their start in a church kitchen or a grass roots outreach effort? We Episcopalians in the Diocese of MT today are not only joining with our brothers and sisters in Christ, but also continuing the ministry of the Saints who went before us!

Finance Department The Rev. Steven Yurosko

The Finance Department's main responsibilities are to create and present the Diocesan Budget each year, review grant requests, and the Parish Audits. In the budgeting process the Finance Department meets to establish a preliminary budget, which is then sent to Diocesan Council for approval. As grant requests are received the finance department reviews them for completeness of submission. Depending on the type of grant, they are passed on to the council or the bishop for further review. The grant is then either

approved or denied. Another important duty of the Finance Department is to make the determination of what health, dental, and vision insurance policy choices are offered. The needs of the diocese are determined as to how many units of single, family, and single plus spouse or children are needed. The committee then reviews all options and chooses the ones that are best suited to our diocese.

Members of the Finance Department are; Diocesan Treasurer, The Rev. Steven Yurosko; The Rev. Rick Johnson; Mark Dvarshkis, Carl Thomas, and Kathy Thomas who also serves as secretary. Barb Hagen is the liaison with the diocesan office.

Foundation Board The Rev. Steven Yurokso

The Foundation Board consists of members who are elected for 3 years terms at the annual Diocesan Convention. Meetings are held quarterly with Brandon Costley from RBC Wealth Management to review the investment portfolio. With the advice of Brandon, decisions are made to change asset managers, add different asset classes, or to continue with the current funds and their managers.

Members of the committee include The Rt. Rev. Marty Stebbins; Chancellor Brad Foster; Diocesan Treasurer, The Rev. Steven Yurosko; Standing Committee President, The Rev. Donna Gleaves; Foundation Secretary, Barb Hagen; Diocesan Council Vice-President, The Rev. Dorcie Dvarshkis; The Rev. Rick Johnson, Michael Moffitt and Don Gimbel.

The Foundation Board manages quasi-endowment funds for the Diocese and also for seven churches, as well as some permanent Diocese endowment funds, through RBC Wealth Management. The Foundation Board meets quarterly with the RBC investment manager to review the investment landscape and portfolio performance, guided by the Foundation Board's investment policy statement and the socially responsible investing polices of The Episcopal Church.

The total quasi-endowment investment balance as of December 31, 2019 was \$2,030,924.48, with \$737,364.75 in in specific church funds and \$1,293,559.73 in Diocese funds. The permanent endowment investment balance as of December 31, 2019 is \$1,602,450.94, with 82.36% of the funds having some restricted purpose.

The Rev. Donna Gleaves President of Standing Committee

The Standing Committee of the Diocese met weekly throughout 2019. Once per month we met in person at Diocese House, the other weeks we met via videoconference.

The purpose of the Standing Committee is to stand as Body of Advice and Counsel to the Bishop, and to serve as the Ecclesiastical Authority of the Diocese in the event there is

no bishop diocesan. The Standing Committee also considers requests from other Episcopal Dioceses requesting consents for the election of bishops, and to consent to the Ordination of bishops-elect. Many of the concerns and materials the Standing Committee works with require both discretion and confidentiality, particularly with regards to personnel and properties, so the Committee meets in closed sessions. In addition to those routine matters that come before the Standing Committee, we work with the bishop to review the spiritual health and vitality of the diocese, consider whether or not to consent to the sale or purchase of real properties, consider and consent to the ordination of persons to the diaconate and presbyterate, and other duties as outlined in the Constitution and Canons of both The Episcopal Church (TEC) and the Diocese of Montana.

Members of the Standing Committee during 2019 were: Cynthia Benkelman, All Saints Columbia Falls; The Rev. Jean Collins, St. James' Lewistown; The Rev. Donna Gleaves, St. Peter's Cathedral, Helena; Rick Harden, St. Peter's Cathedral, Helena; Mary Messina, St. James' Lewistown; and The Rev. Bradley Wirth, All Saints Columbia Falls. During the 2019 Convention, two new members were elected: Laura Catlin, St. James' Bozeman; and The Rev. Terri Grotzinger, Holy Spirit, Missoula. An extension was granted by Convention for the two members who would typically rotate off following convention to remain on until the end of the calendar year. Those two individuals are The Rev. Donna Gleaves and Mary Messina. This extension was granted due to the nature of the work of the Standing Committee when it serves as Ecclesiastical Authority. The new members joined the committee meetings beginning in November as they would do in a normal rotation.

During 2019, in addition to the regular work of the committee, the Standing Committee was responsible for the work of the Bishop Search process, undertaken through the Nominating and Transition Committees. We wish to extend our sincere and grateful thanks to the members of those committees for work well done.

Regular work included such items as consents for multiple bishops-elect, staff transitions at Camp Marshall, planning for the camp season for 2020, planning and running the Election of our new bishop (Special Convention) and our regular Diocesan Convention, ensuring that all matters would be in order prior to the arrival and Ordination of our next Bishop.

We are delighted to welcome our Tenth Bishop of Montana, The Right Reverend Marty Stebbins. Standing Committee members are looking forward to a new year, a fresh start, and a return to the more typical responsibilities of a Standing Committee.

Thank you all for your contributions during 2019. It was a joyful challenge. The outgoing President especially wants to thank the members of the Standing Committee for their diligence, perseverance, and dedication to this Diocese.

UTO (United Thank Offering) Vicki Van Rensselaer Diocesan UTO Coordinator

United Thank Offering staff members have reported that during calendar year 2019, United Thank Offering received \$3,251.43 from individuals and parishes located in the Diocese of Montana. Of that amount, \$2,279.41 was collected at a UTO Ingathering that was held on Saturday, July 27, 2019 during the 2019 Diocesan Convention that took place in Bozeman. Seven parishes in the Diocese of Montana have reported that they held UTO Ingatherings during calendar year 2019. Five parishes held their Ingathering shortly before the 2019 Diocesan Convention took place, one parish held its Ingathering on Christ the King Sunday and one parish held its Ingathering on Mother's Day.

2019 ANNUAL REPORT – TOGENDOWAGEN SOCIETY

The Togendowagan Society is an inter-tribal Native American Spirit Society, comprised of both native and non-native persons journeying together to Creator.

In 2019, 12 services followed by meals were held at St. Peter's Cathedral. Total attendance at all services was 297 with 143 communions received. One funeral were held by Dean Brown. Elder Bill Fenton and the Magpie Singers for Nicholas Vrooman historian of the Little Shell Tribe and greatly influential in their federal recognition.

It was a tumultuous year. Our previous elder and spiritual leader, Bill Felton moved to Post Falls, Idaho shortly after the New Year. At no cost, he continued to commute to Helena for our services. A 600-mile round trip. New leaders were needed. Society members wanted to continue. Darcy O'Dell and Dan Pocha stepped forth. Services and meals continued through November and December with a great commemoration on Christmas Eve, the 15th Anniversary of the Togendowagen Society.

At the Consecration of the Marty Stebbins as the 10th Bishop of Montana on December 7th, the Togendowagen Society Drummers offered an honor song to Bishop Stebbins. Presiding Bishop Curry joined the drummers. Bill Felton gifted our new Bishop with a prayer bundle which was circulated among the congregation for their prayers and then presented to Bishop Stebbins.

The Society continues to meet on the second and fourth Saturdays of each month as we have for many years.

No leaders of drummers receive compensation. Meals are offered by society members. No one goes hungry. It is a great honor and privilege to serve the Native Peoples of this community.

Our deep appreciation is extended to St. Peter's Cathedral and the Diocese of Montana for their support. Bishop Marty is an inspiration. To our knowledge, this is only such service in the Episcopal Church. It has been and is an important ministry.

Camp Marshall Facility Annual Report From the Site Manager Mark Clemow

As I look back on the year, the biggest thing I can take away is that 2019 was an amazing year! I began the year living in Kalispell, enjoying the time off from my seasonal job doing concrete at Knife River and shoveling snow to stay busy and make some extra money. As I am sure you all remember February was a crazy month of non-stop snow, so I wasn't able to enjoy as much of that time off as I wanted to. In March I learned that Julie Sisler had decided to resign from her job at Camp. After a lot of thought, prayer, and discussions with my family, as well as with Julie, I decided to apply for the Site Manager job. Camp has been a huge part of my life since I was young and after all of

those thoughts and prayers it became clear to me that I didn't want to be any other place besides camp. Thankfully after a very long interview with Director Sue LaRose and Program Director Paul Carlson-Thompson they decided to offer me the job and I very happily accepted! Julie had set the end of March as her last day and before that she was kind enough to let me come down to camp and help her with her final rental group. Throughout that day I was able to pester Julie to no end with any and all questions I could think of to do with the job, without that day with her I would not have been able to hit the ground running as well as I like to think I did. Thank you Julie!

Hit the ground running I did indeed. I moved down to Camp from Kalispell on April 1st. As I was getting all settled in, Blake Holman had begun to remodel the shower house by the lodge. The remodel has been a long time coming and succeeded in giving us an ADA approved bathroom that is more easily accessible than any we had previously had. On my second day Sue LaRose and I did a walk around of camp and discovered that the pump for the well by the Bishop's trailer had frozen over the winter and had since burst so we made some quick calls and were able to get Oh Well Drilling out there to fix it right away. The beginning of May brought with it great weather—so I was able to paint the outside of the new shower house—and also the annual Clergy Conference. Though I was little a nervous to start and the coffee cake didn't quite turn out the way I wanted, everyone seemed happy with the retreat. The Rev. Chris Roberts Canon to the Ordinary

From February of 2011 through November of 2018 it was my honor and pleasure to serve as Canon to the Ordinary for Bishop Brookhart. With his retirement November 1, 2018, I was asked by the Standing Committee to continue to serve in this ministry in the transition period between Bishops and I did this all of the year 2019. I worked this ministry with the support and guidance of the Diocesan Standing Committee. Since November 1st of this year I have helped our new Bishop Marty Stebbins as she transitions into her new position. My position is a half-time, approximately three-day-a-week position. Each week I spend a day or two in the Helena Office, a day in the Virginia City Office, and a flex day which may be on the road, on the computer and smart phone, at a Diocesan Event or in one of the offices. In addition, in order to provide a servanthood ministry, I work by phone and computer internet on any other day of the week on which my support may be required. It is an exciting time of growth and transition in our Diocese and I am honored to be asked to help with this next stage in the life of the Diocese of Montana.

This year I have served in at least the following areas of Ministry:

Diocesan Deployment Officer and Officer of Transition Ministry:

I have worked this year as the Standing Committee's primary support in the search process for new clergy for empty positions in Montana. In this position I have assisted the Vestries, Cluster Boards and Search Committees of Congregations in their Discernment, Search and Call processes, with all that may be needed in each unique I have provided and managed the training of Vestries and the Search Committees they appoint. I have provided all initial background and reference checking of potential candidates, making contact by phone with each candidate and generally my counterparts in their Dioceses. Working closely with the Standing Committee, I have supported it in the discernment of our Congregation's needs and the suitability of potential candidates in order for it to make the decision as to whether the Candidate's name will move forward in the Discernment and Call process. Once the names of Candidates have been presented to a Search Committee, I have offered ongoing support and advice in their process. I have worked with four Congregations in at least some part of their Search Process this calendar year. Our goal has been to create an efficient, people friendly and flexible process which honors the National Guidelines provided in our Canons as well as those provided by our National Office of Transition Ministry. Our chief hope is to find quality candidates for our quality Congregations. It has been an honor to support the gifted lay and ordained leadership we have in this Diocese.

Ordination Officer

As Diocesan Ordination Officer, I file an annual report with the National Church. This report lists all active and retired clergy, all transfers, all ordinations and reports any disciplinary actions that may have occurred in our Diocese. I also manage all transfers

of Clergy "Letters of Dimissory" in and out of the diocese, and manage all ordination files.

Management of Ordination Training

I provide support for all individuals who are in any stage of the Ordination Process. This involves file and record keeping, support as individuals work through canonical requirements and regular communication with individuals, their clergy and occasionally their congregations. I serve as a support and resource for our excellent Diocesan Commission on Ministry.

Management of all Diocesan Confidential Files and Clergy Background Checks

All confidential clergy files which come to the Diocesan office are filed and managed by me personally. Much of my work is involved in management of the files and oversight of Clergy Background Checks.

Congregational Support and Visits

A part of my work commitment includes informal as well as formal visits and Worship Services at diocesan congregations and diocesan meetings (including COM and occasional Clergy Deanery meetings). I have Celebrated HE and Preached many times this year. I have been an active leader in Diocesan Training events and I have assisted with Ministry reviews and Congregational visioning processes.

Priest Support

In addition to the responsibilities previously mentioned I have helped manage the Supply Clergy list, with the assistance of our Administrative Assistant. It is always a great joy to be a part of our Annual Diocesan Convention.

Miscellaneous

Much of my work involves regular participation in Diocesan Staff fellowship, planning and daily worship. I am often called to support clergy and congregations with unplanned needs and issues; in fact, I often find myself working on unexpected needs and issues. Most importantly, I have sought to assist and support the Standing Committee, and since November 1st to support our new Bishop, Marty Stebbins in the guidance and empowerment of ministry in this Diocese.

It has been my pleasure and honor to serve this Diocese for the year 2019.

Barb Hagen Canon for Finance & Administration

I again offered phone call/online workshops in 2019

- January year end payroll call with Beth Baker 2 people called in
- February new treasurers -2 people called in
- February audit training 2 people called in
- March vestry training no one called in

I attended the Client Council for the Church Pension Group in New York City in March. This is the second year of a three year term on the Client Council. The council is comprised of 28 members – bishops, priests, deacons, diocesan administrators, senior wardens. They are from all over the world and so there are many voices at the table. The Church Pension Group invites our feedback and they want to have conversations about what we need in our churches and dioceses and how the Church Pension Group can better serve us.

I updated the training videos for vestries, audit teams and treasurers in 2019 and plan to update them each year.

This was a very busy summer and due to the election in July I did not attend the Episcopal Relief & Development network meeting or the Business Partnership Conference with the Church Pension Group in the spring. The Rev. Mary Alice Jones, Diocesan Disaster Coordinator represented the Diocese at the Episcopal Relief & Development network meeting.

I surveyed the network reps for Episcopal Relief & Development regarding their work and how I might support them. In November, St. Peter's celebrated Episcopal Relief & Development by again holding a dinner. They also invited the Diocesan Disaster Coordinator to work with the vestry on disaster preparedness and she did a presentation that evening at the dinner as well.

In June, I went to Bozeman to work on their audit. Please remember I am available to help with audits and we are also have a team of people around the diocese who can help. If you are interested in serving on an audit team, please let me know.

Audit compliance continues to be a struggle in our diocese. For 2019, 71% of the churches submitted their audits on time. Audits are due September 1 each year and this is a canonical requirement. We provide training for audit teams via GoToMeeting and we have a quick video tutorial available any time. My goal for 2020 is to increase our

diocesan audit team members which I hope will lead to greater compliance with the 2019 audits.

We had many extra meetings with the transition this year and a July convention was challenging. We squeezed a lot into a short time!

The summer was again consumed by handling camp administration. Most of my work involves payroll and additional financial reporting. Each year, the camp director hires about 25 extra people and I need to process all of their payroll in addition to the additional camp fees to process and bills to pay.

I also staff the Finance Committee, Foundation Board, and Diocesan Council and prepare for and attend those twelve meetings each year. Finance meets via phone call four times per year and once in person in the summer.

I again helped coordinate diocesan convention. I led an in-person new delegate's session as well as leading the budget hearing for convention and helped with the ballot process for the election.

I was blessed to be invited to read at the Bishop's Ordination service. It was a glorious celebration and I look forward to seeing what the future will bring with our new bishop.
